

Pre-Qualification Criteria For the Supply of Aluminum Tubes for CACA coolers

The bidder shall produce documentary evidence for meeting the following Pre-Qualification Criteria Along with their offer.

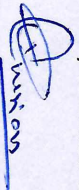
S. No.	Criteria	Documents required to be submitted/confirmation in support of claim	Bidder's Response
1.	a. Bidder should have established facility to in-house manufacture & test finished aluminum tubes as per technical spec. IS-1285 (2002), GR.63400-T4. Mechanical and chemical testing to be done by NABL approved lab or NABL calibrated instruments. b. Traders with supply of tubes from reputed manufacturer are also acceptable. In this case, bidder to mention the name of manufacturer (which shall be binding for the contract) and confirm regarding availability of MTC from manufacturer meeting 1.(a) . In absence of above, tests are to be carried out by bidder at NABL approved labs as per technical spec. IS-1285 (2002), GR.63400-T4.	a. Bidder to submit supporting document (list of machinery, equipment, testing facility) for aluminum tubes. b. Confirmation of mechanical & chemical test as per 1.a. c. Traders to furnish manufacturers name for aluminum tube.	a. submitted/ not submitted b. Yes/No c. Manufacture name:
2.	a. Bidder has to submit one performance certificate from end user for successful satisfactory operation of aluminum tube for minimum 01 year as on date of bid submission for at least one purchaser. Alternatively, To establish meeting this requirement, bidder has to submit minimum two purchase orders from same purchaser with the gap of one year (min.) between supply completion of 1st PO and Placement of 2nd PO aluminum tube. Note: 1. In case of trader, above documents shall be for supply of tube from Same manufacturer as mentioned above in 1(b). 2. Credentials of manufacturer are also acceptable. b. To establish business continuity, Bidder is required to submit at least two (02) PO of Aluminum tube in last three (03) years from due date of bid submission.	a. Performance certificate from end user stating that supplied tubes are in operation and performing satisfactory for at least one year. OR Copy of 2 nos. POs from same customer (showing date of PO, item description, name of customer, etc.) meeting requirements of 2(a) with documents in support of supply completion like material dispatch clearance certificate (MDCC) or Material receipt certificate (MRC) or delivery challan or any other valid document for first PO. b. 2 nos. un-priced PO (showing date of PO, item description, name of customer, etc.) meeting requirement of 2(b).	a. 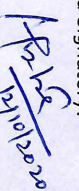

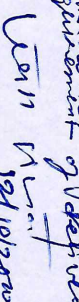
