

1. The offer has to be submitted in TWO PART BID. Part-I Technical and Commercial (Un-priced Bid) in a sealed cover. Part-II Price Bid in a separate sealed cover. Both the above sealed covers should be put in a separate sealed cover. All the covers should be super scribed with Tender No, Due date & Description of item.
2. Please quote the price on FOR DESTINATION – Door delivery BHEL, HINDALCO, Orissa Site
3. Rates quoted shall be inclusive of all taxes, duties, Octroi and Entry tax etc. on FOR Destination – Door delivery basis. Supplier should furnish ED details separately in their offer / invoice, for BHEL to avail CENVAT benefits. The ED value will be deducted while comparing your offer to arrive L1 status. We will not furnish any ‘C’ Form.
4. BHEL reserves the right to go for Reverse auction (RA) instead of opening the sealed envelope price bid submitted by the bidder. Bidders to familiarise themselves with Guidelines for Reverse auction 2016 which is part of this Tender. This will be decided after techno- commercial evaluation. All bidders to give their acceptance for participation in RA. Non acceptance to participate in RA may result in non-consideration of their bids. In case BHEL decides to go for RA only those bidders who have given their acceptance to participate in RA will be eligible. Those bidders who are consenting to participate in RA will have to necessarily submit “on line sealed bid” in the RA. Non submission of “on line sealed bid” by the bidder will be considered as tampering of the tender process and will invite action by BHEL as per extent guide lines in vogue”. Bidders are also required to furnish following details in their techno commercial bid, for this purpose (RA).
5. Authorization of representative who will participate in the on line reverse auction process;
 - i. Name and designation of official.
 - ii. Postal Address (Complete).
 - iii. Telephone Nos.(Both Land line & Mobile).
 - v. FAX No E-mail address.
 - vi. Name and Place /State/Country, where from he will participate in the reverse auction.
6. 100% payment will be released within 30 days on receipt of materials against Site Receipt Voucher issued by the consignee.
7. **TESTING/ INSPECTION / DELIVERY PERIOD:**

Material shall be inspected by BHEL/ BHEL authorised Third Party Inspection Agency. Bidder to raise online Inspection call in <http://cqir.bhel.in/Cqir/jsp/Masters/login.jsp> website on either of the Inspection agency as advised by BHEL at the time of Inspection. Inspection will be carried out as per BHEL approved procedure for testing of EDTA solution.

ANNEXURE- I SPECIAL TERMS AND CONDITIONS

Supplier is requested to ensure the testing facilities are made available and the material supply should conform to the specification as per our enquiry. Material should be offered for inspection within 10 days of receipt of order and should be despatched to site within 10 days of Material dispatch clearance from BHEL. However, the site may please be contacted for their exact requirement and despatches shall be effected accordingly.

8. Manufacturer's Test Certificate Guarantee Certificate to be furnished along with supply without fail. Please refer to the instructions to Tenders regarding General Purchase Terms & Conditions as applicable to this Enquiry, which is enclosed.
9. Packing of the chemicals shall be in such a way for easy handling at sites.
10. Please seek all the clarifications, if any, before quoting and submit a "NO DEVIATION CERTIFICATE", agreeing to all our terms and conditions.
11. Vendor has to submit MATERIAL SAFETY DATA SHEET for Transportation & Handling the above chemicals along with the offer.
12. Vendor should transport the chemical through reliable transporters who have proven facilities for safely transporting such chemicals. **(Emergency Management Card should accompany during supplies).**
13. Legal compliances such as Factories Licenses, Consents to operate from State Control Boards (SPCBs) & Hazardous Waste Authorisation from SPCBs (if applicable and relevant) shall be furnished.
14. If the chemical is transported through tanker and unloading at destination is delayed beyond two days, a sum of Rs.1200/- per day for supplies up to 10MT tankers, Rs.1500/- per day for supplies up to 15MT and Rs.2000/- per day for more than 15MT will be paid as tanker detention charges up to the date of tanker release beyond two days.
15. The offer validity should be 90 days from the date of opening of Tender.
