Qualifying criteria - Pre-Qualification Requirement (PQR)

Pre-Qualification Requirements (PQR) for FORGED MACHINED & UN-MACHINED AL BLADES:

Intending firms / Vendors shall comply and fulfill the criteria of satisfactory execution of similar products as given below as minimum requirements:

Vendors who satisfy the following criteria can only quote.

PRE-QUALIFICATION REQUIREMENTS (PQR)

1. Bidders, who had already supplied the Forged Blade to BHEL/BAP Ranipet, need not to submit PQR documents. Offer from the suppliers are acceptable subject to Techno-Commercial acceptance.
2. New bidder for the product, but already registered with BHEL Ranipet, has to Submit Purchase order copy with technical details of similar item to substantiate the technical competency.
3. New bidder, who are not registered with BHEL Ranipet has to submit following PQR documents.
 - a) Only manufacturers can submit quotations, dealers are not permitted. Bidder has to provide necessary Test Certificates (Mechanical properties, Chemical Properties, Dimensions Certificate, Radiographic Test Certificate Ultrasonic Test Certificate etc.), Guarantee Certificate along with supply.
 - b) Bidder should offer Forged AL Blades (Machined and Un-Machined) as per BHEL



Drawings and as per Specification TFN:364 REV.02 without any deviation.

- c) Bidder should have supplied similar size/type of Forged AL Blades for thermal power station fan.
- d) Blade (Forged) supplied should be in continuous operation for at least one year as on the date of technical bid opening.
- e) Supplier to provide full technical details and years of operation of supplied blades.
- f) Supplier to submit credentials of client i.e. customer name, contact person, phone No., email etc. as a part of reference along with the offer.
- g) Supplier have to submit Purchase Order copy and commissioning report to substantiate the supply of blades.
- h) Bidder should have annual manufacturing capacity more than the tender quantity. New Bidder who have not been registered with BAP BHEL Ranipet have to submit Copy of Annual Report/Statement of Profit and Loss Account certified by Chartered Accountants together with a certified copy of audited Balance Sheet.
- i) Bidders shall not have been black-listed / kept on hold / given Business holiday for a specified period by any Public Sector Undertaking or Government Departments/any other units of BHEL.
- j) BHEL, Ranipet reserves the right to verify the information provided by vendor. In case the information provided by vendor is found to be false / incorrect, the offer shall be rejected
