- Container shall be of cargo worthy with at least **Three** years left out on the date of offer.
- Vendors have to submit the offer with clear picture of proposed containers.
- Offer should be with clear container numbers and successful bidder should be able to furnish cargo worthy certificate by third party agency like M/s. J B Boda
- BHEL reserves the right to visit to physically inspect the containers before issue of order.
- Delivery term is to be: BHEL Ranipet stores and material should ready for inspection Within a week from the order.
- The container will be used to move several parts from BHEL-Ranipet to various BHEL consumers in India only.
- Container will not be used to move the cargo outside Indian Territory.
- Material of the container Mild Steel or Corten steel
- General cargo container for general purpose
- Domestication charge should be included in the price.

Pre-qualification Criteria.

The vendors are required to meet the qualification requirement for supplying Containers as per criteria stipulated below.

- 1) The bidder should have the container in his possession and the ownership should be transferred within 6 week from the placement of order without any financial implication.
- 2) Supplier should have successfully supplied at least 1/3 of enquiry QTY in the last two years. Relevant purchase order should be enclosed along with quotation as a proof.
- 3) Financial standing through latest I.T.C.C, Annual report (Balance sheet and Profit and Loss Account for last 3 Years.

Quantity Split:

BHEL reserves the right to split the tendered quantity against each enquiry in the ratio of 70:30 among the L1 and L2 vendors respectively. The L1 rate will be counter offered to the L2 vendor and upon acceptance of the counter offer, PO will be placed on L2 vendor for 30% of the enquiry quantity. If L2 vendor does not accept counter offer, it will be counter offered to next higher bidders leaving out H1 bidder (i.e., H1 bidder will not be given any counter offer) and also if no one accepts the counter offer, the entire enquiry quantity will be ordered on the L1 vendor. Pl note that delivery should be staggered as per our Enquiry. No advance delivery acceptable to us. BHEL may revise the Delivery Schedule / Qty depending up on production requirement and the vendor has to supply accordingly.
