- Specification and BHEL TDC to be complied with in toto.
- BHEL's Delivery requirement to be met.
- Manufacturer's Test Certificate to be sent along with the material.
- Inspection before dispatch by BHEL/TPI.

1. Qty Split not applicable. Rate shall be quoted in per Number basis only & P.O will also be placed on number basis. However Reverse Auction alone will be conducted on Rate/Mtr basis section wise.

2. Offer for partial quantity is not acceptable and such offers will not be considered for further process for that item.

3. Quantity Tolerance: +/-5 % applicable; Supplies beyond this tolerance will be rejected and returned back to the supplier.

4. Annexure A is to be duly signed, scanned and uploaded during submission of offer. Pointwise specific confirmation to BHEL TDC to be given in the Techno-Commercial Bid without fail; otherwise offer may not be considered.

5. In case of supplies from any new foreign suppliers, who are not in BHEL Product Material Directory, material inspection shall be carried out by Third Party Inspection Agency like Lloyds or SGS or BVQI prior to shipment at Supplier's work and total inspection charges shall be borne by the supplier only. (Quoted price shall be inclusive of TP inspection charges). For indigenous suppliers, first inspection will be carried out by BHEL only and subsequent inspections will be by BHEL/BHEL approved Third Party Inspection Agencies.

6. In case of offer with equivalent material grade, then copy of the entire specification of that equivalent grade shall be sent along with the techno-commercial bid without fail.

7. Offer to be submitted through Enterprise Procurement System (EPS) only .In case of direct hard copy offers, the same will be returned to the supplier without opening.

8. In case Integrity Pact is applicable, then two original signed copies (duly filled in, signed & stamped) of Integrity Pact to be sent directly to The Deputy General Manager, Purchase Department (Steel), BHEL, BAP, Ranipet - 632406 by superscribing the tender & NIT No on the envelope without fail and ensure that the same is reaching us on before the tender due date.

9. In case of Foreign Suppliers, BIS registration certificate as per Ministry of Steel Order, Dt 16.02.2018 is mandatory.
