2. In case of supplies from any new foreign supplier, material inspection shall be carried out by Third Party Inspection Agency like Lloyds or SGS or BVQI prior to shipment at Supplier's work and total inspection charges shall be borne by the supplier only.								
3. In case of offer with equivalent material grade, then copy of the entire specification of that equivalent material grade shall be sent along with the techno-commercial bid without fail for our verification and acceptance.								
4. Offer has to be submitted through e-Procurement System (EPS) only .In case of direct hard copy offers, the same will be returned to the supplier without opening.								
5. Annexure A is to be duly filled in, signed, scanned and to be submitted during submission of offer.								
6. Invoicing shall be on Theoretical weight basis with Density 8.00 Kg/dm3. In case the supply is on Actual weight basis, then suitable loading on cost will be made based on the maximum allowed tolerance on thickness as indicated in the relevant standard. (Theoretical Weight + %age of maximum allowed tolerance limit on thickness)
