

1. Rates have to be **quoted FOR BHEL Rudrapur basis** only with 100% payment after supply of machine at BHEL Rudrapur and within 45 days subject to successful acceptance. Any deviation in payment terms will be loaded @ (SBI Prime Lending Rate on technical bid opening date +6)% annual interest for comparing standing
2. The validity period of the quotation must be for 3 months from the date of quotation.
3. **Supply** of the machine at BHEL Rudrapur within **01month** from the date of placement of Purchase Order.
4. In case of any deviation in delivery terms, loading on offer will be done (0.5 % per week, maximum up to 10 %) for comparing L1 standing
5. Supplier has to **submit performance Bank guarantee @10 % of PO value** from the date of acceptance by BHEL . PBG shall be furnished in a prescribed format and from one of the consortium banks of BHEL. PBG shall be valid up to 30 days beyond warranty/guarantee period.
6. **Warranty-minimum one year** from the date of acceptance by BHEL.
7. Offers to be submitted in **Two part bid** system i.e.in two separate envelopes sup scribed as **(I) Technical bid containing technical offer along with Commercial Term and conditions+ un-priced copy of the price bid only (II) Price bid containing only price of the items.** Offers submitted in single bid shall not be considered.
8. TC/GC required with material.
9. Supplier shall submit catalogue/full specification & **Annexure-II (Terms and Conditions)** and send the same along with your offer (**signed & stamped**) else offer shall be liable to reject.
10. **Cutting capacity 0.4 mm to 1.0 mm thickness, cutting length 1000-1200 mm, cast body, foot operated (manual).**
11. Bidder required to submit past experience documents (Invoice and POs of past supplies having similar scope-not older than 2 years). **(This is mandatory and pre-qualification requirement).** If any bidder fails to submit these documents his offer will be liable to reject.
12. List of recommended spares and operation & maintenance manual (2 copies) required with machine.
13. **Risk Purchase clause shall be applicable with this enquiry.**

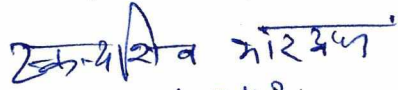
RISK PURCHASE CLAUSE: On finding non-supply of the PO as per PO delivery terms, BHEL may sources the material from any alternate arrangements/orders. On such occasions, the difference of amount shall be recovered from pending / subsequent bill(s) of original supplier.

14. LD/Penalty clause shall be applicable with this enquiry.

The delivery of goods shall be made strictly as per time limit specified in delivery schedule. Failure to supply within this period will make the supplier liable to a penalty of ½% (half percent) of the total order value per week of delay or part thereof subject to a maximum of 10% of the total order value for the reasons attributable to the party.

Non acceptance of above clauses shall be considered as deviation to this tender and shall be loaded at the rate of 10% for each case for comparing standing

15. The offer must reach at our office on or before due date. Late offers shall not be considered received after due date even if posted by speed/register post before due date.
16. For terms & conditions other than mentioned here, the bidder should go through the terms and conditioned mentioned on reverse of Enquiry format (**Annexure-A**) before submitting their offer.
