1. Rates have to be **quoted FOR BHEL Rudrapur basis** only with 100% payment after **supply & Receipt** of Jib crane at BHEL and **within 45 days** subject to successful **Erection & commissioning** of Crane. Any deviation in payment terms will be loaded @ (SBI Prime Lending Rate on technical bid opening date +6)% annual interest for comparing standing
2. The validity period of the quotation must be for 3 months from the date of quotation.
3. **Supply** of the Material/machine at BHEL Rudrapur within **06 weeks** from the date of placement of Purchase Order and Erection & commissioning of it within **03 week** from the date of receipt of material at BHEL.
4. In case of any deviation in delivery terms, loading on offer will be done (0.5 % per week, maximum up to 10 %) for comparing standing.
5. Late Delivery penalty shall be applicable @0.5% per week.
6. Supplier has to **submit performance Bank guarantee @10 % of PO value** from the date of acceptance by BHEL (Date of successful commissioning). PBG shall be furnished in a prescribed format and from one of the consortium banks of BHEL. PBG shall be valid up to 30 days beyond warranty/guarantee period.
7. Warranty-minimum one year from the date of successful Erection & Commissioning of Crane.
8. Offers to be submitted in **Two part bid** system i.e.in two separate envelopes subscribed as **(I) Technical bid containing technical offer along with Commercial Term and conditions+ un-priced copy of the price bid only** (II) **Price bid containing only price of the items**. Offers submitted in single bid shall not be considered.
9. TC/GC required with material.
10. Supplier shall confirm compliance of **Annexure-I (Specification of 3 MT Jib Crane) & Annexure-II (Terms and Conditions)** and send the same along with your offer (**signed & stamped**) else offer shall be liable to reject.
11. Bidder required to submit past experience documents (Invoice and POs of past supplies having similar scope- Value of invoice should not be less than 02 lakh and not older than 3 years). **(This is mandatory and pre-qualification requirement).** If any bidder fails to submit these documents his offer will be liable to reject.
12. Supplier shall submit catalogue of item/machine along with offer(Along with techno-commercial bid)
13. After erection & commissioning of Jib crane supplier has to provide **training to BHEL person(s)**.
14. List of recommended spares and operation & maintenance manual required with machine.
15. The offer must reach at our office on or before due date. Late offers shall not be considered received after due date even if posted by speed/register post before due date.
16. For terms & conditions other than mentioned here, the bidder should go through the terms and conditioned mentioned in **(Annexure-A)** before submitting their offer.
17. **Special Note regarding GST**-BHEL will evaluate offers of all bidders or "cost to BHEL" basis and the eligible input credit of GST (including IGST, CGST, OR UGST whichever is relevant) likely to be passed on by bidders to BHEL will be reduced from total cost to arrive at "cost of BHEL".
