Sub: Public Procurement Policy for the Micro and Small Enterprises (MSEs) Amendment Order, 2018.

Vide Gazette notification dated 09.11.2018, Ministry of MSME has issued Public Procurement Policy for the Micro and Small Enterprises (MSEs) Amendment Order, 2018 (enclosed) as per which following amendments in the Public Procurement Policy for the Micro and Small Enterprises (MSEs) Order, 2012 have taken place:

- a) Increase in percentage of procurement of goods and services from MSEs from the present at least 20% to at least 25%.
- b) Minimum of 3% reservation for women owned MSEs within the above mentioned 25% reservation.
- c) Increase in procurement target from MSEs owned by SC/STs from the existing 4% to 6.25% (25 percent out of target of 25 percent - refer para 4 of Public Procurement Policy for the Micro and Small Enterprises (MSEs)).
- d) In tenders, reservation of 25% quantity in place of 20% for MSEs quoting within price band of L1+15% (refer para 6 of Public Procurement Policy for the Micro and Small Enterprises (MSEs)).

Above amendments have come into force w.e.f. 09.11.2018.

To achieve the same, Unit/ Region/Divisions are requested to

- i. Revised their mandatory procurement target from MSEs to at least 25%.
- ii. MSEs owned by Women entrepreneurs are to be identified and procurements to be encouraged from such MSEs alongwith MSEs owned by SC/STs to achieve the stipulated targets as above.
- iii. In tenders, reserved quantity for MSEs quoting within L1+15% price band to be increased to 25% from existing 20%.

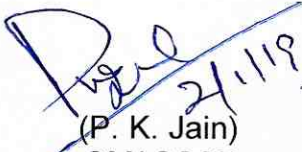

Sub: Public Procurement Policy for the Micro and Small Enterprises (MSEs) Amendment Order, 2018.

In continuation to our Circular no. 44 of 2018-19 regarding amendment in Public Procurement Policy for the Micro and Small Enterprises (MSEs) Order, 2018. The definition for MSEs owned by Women Entrepreneurs is clarified as under:

- i. In case of proprietary MSE, proprietor shall be Woman.
- ii. In case of partnership MSE, the Women partners shall be holding at least 51% share in the unit.
- iii. In case of Private limited companies, at least 51% share shall be held by Women promoters.

This issues with the approval of Competent Authority.
