(i) This Enquiry is for entering into Rate Contract for the procurement of **C276 FASTENERS**. Contractual period shall be **one year** from the date of finalization of the Rate Contract for ordering.

(ii) The Rate Contract Period for One year means twelve months from the date of Rate Contract Letter of Intent/ Purchase Order. Addendum Purchase orders shall be placed for firm quantities as and when required.

(iii) The quantities indicated in the enquiry are tentative only. The quantities are not guaranteed requirement. It may increase / decrease. However, BHELs' present firm requirement is as per table given below.

(v) The rates shall be firm till completion of supplies.

(vi) Bidder shall indicate their delivery capacity (per month) in their commercial offer.

(vii) **Vendor shall offer their prices on F.O.R. BHEL Stores, Ranipet basis i.e. price shall be inclusive of Packing, Forwarding, Freight & Insurance.**
