GENERAL TERMS & CONDITIONS

1. Any Indian individual, Sole Proprietorship Firm, Partnership Firm, Public Limited Company or a Private Limited Company is entitled to get enlistment as a contractor in BHEL under these Terms and Conditions, provided the eligibility criteria and other norms are satisfied. The enlisted contractors have to abide by all the rules made herein and as amended from time to time during the currency of their enlistment.
2. No individual or a firm having such individual as one of the partners, who is a dismissed government servant or removed from the approved list of contractors or demoted to lower class or having business banned/suspended by any government department in the past or convicted by a court of law shall be entitled for enlistment.
3. No Engineer or any other official employed in Engineering or Administrative duties in the Engineering Departments of the Government of India is allowed to work in BHEL either as contractor or as employee of a contractor for a period of two years after his retirement from Government service unless he has obtained prior permission of Government of India to do so. Even after enlistment, if either the contractor or any of his employees is found to be a person who had not obtained the prior permission of Government of India as aforesaid, the name of the contractor shall be removed from the list of enlistment.
4. Any applicant is not permitted to have enlistment in more than one name.
5. A partner of a firm or a director of a company enlisted as a contractor cannot be a Partner/Director in any other enlisted firm/company.
6. The enlistment in BHEL shall only entitle them to be considered for issue of tender notice subject to the conditions laid down in Notice Inviting Tenders(NIT). It shall not confer any right on them either to be necessarily issued the tender papers or for award of work.
7. The applicant shall have to submit the application in prescribed form to enlistment authority complete with all relevant documents.
8. Incomplete applications and applications not accompanied with necessary documents are liable to be rejected.
9. The enlistment authority shall have the right to verify the details furnished by the applicant.
10. If the enlistment authority finds the applicant suitable for enlistment, it shall issue the enlistment order and, otherwise, send a letter of rejection of the application to the applicant. The decision of the enlistment authority shall be final and binding on the applicant.
11. **The enlistment will be valid for three years from date of approval of competent authority and every year it has to be renewed and updated for any change. Vendor directory shall be reviewed once in a year and the IT Return, Balance sheet, Profit & loss account shall be submitted every year failing which shall lead to delisting.**
12. The enlistment will be done for classes as mentioned in the application form and in case the applicant is not found suitable for the class applied, then the applicant will be registered in the next eligible lower class, if suitable and eligible.
13. The financial soundness shall be judged on the basis of the solvency certificate or the working capital certificate, as the case may be, issued by the Bankers of the contractor. Such certificate shall

- be issued by a scheduled bank and shall be submitted in original in a bank sealed cover, addressed to the enlistment authority.
14. The applicant shall have to pay a non-refundable enlistment fee by crossed Demand Draft drawn in favour of BHEL,Trichy-14. For Class I & II, the enlistment fee is Rs. 5,000/- and for Class III, IV & V - Rs.2,500/- which is to be submitted along with application form. The application without enlistment fee will be summarily rejected. **There is no need to pay more than one enlistment fee to get enlisted in more than one category.**
 15. **The applicant shall produce IT return filled and acknowledged by IT office along with his application for enlistment. After enlistment, he shall have to file IT return for every year and submit the attested copy of acknowledgement issued by IT office to the enlistment authority by November every year. Failure to submit the IT return in this manner will render the contractor liable to be removed from the approved list of contractors.**
 16. The applicant / firm shall not modify the existing partnership or enter into any fresh partnership without the prior approval of the enlistment authority. Such proposal, if any, shall be submitted in advance giving full details of the intended partnership/sole proprietorship along with the draft partnership deed / affidavit and documents. Any change in status of the contractor as an 'individual' or in constitution of the firm without prior approval of the enlistment authority will render the contractor / firm liable to be removed from the approved list of contractors.
 17. If a firm is converted in two or more firms by any action of its partners, the new firm(s) or any separated partner(s) in his (their) individual / joint capacity shall have to apply for the enlistment afresh on the basis of work experience gained as a separate entity.
 18. If new partners are taken in the firm, each new partner shall have to satisfy the conditions as mentioned in Sl.Nos.1, 2 & 3.
 19. If the number of original partners of a firm reduces to less than half due to any reason including death of partner(s), the enlistment of the firm shall be withdrawn.
 20. Change in address
(a) While applying the enlistment, the applicant should mention address of the Registered Office as well as Head Office, if different. All documents i.e. Solvency Certificate, etc should bear one of the above addresses, otherwise the same shall not be accepted.
 21. The applicant shall have to abide by all the rules, terms and conditions of the contract and the Notice Inviting Tenders. He shall have to execute the works satisfactorily on time and with good quality. In case of failure the enlisting authority shall have the right to demote a contractor to a lower class, suspend business with him for any period, debar him or remove his name from the approved list of contractors after issue of show cause notice. Decision of the department shall be final and binding on the contractor.
 22. **BHEL reserves its right to modify, add, delete and / or change any of the above terms and conditions and the same shall be binding on all the applicants and enlisted contractors.**
 23. **The applicant should submit the following to meet out the qualification norms and eligibility criteria of the tender value for which the application made.**
 1. **Proof for registration under ESI,EPF & Service Tax authorities.**
 2. **Proof for registration of PAN (Permanent Account Number).**
 3. **Proof for registration under Service Tax authorities.**

01. The scope of work involves:-
 - a) Construction of Structural Steel Industrial Buildings and RCC Buildings coming under Expansion and Special Schemes in BHEL, TIRUCHY.

04. The value of turnover and the value of similar works mentioned above excludes cost of cement, steel reinforcement and structural steel. However if the turnover value furnished by the applicant includes the above materials, then the applicant has to furnish the cost of the same separately. Attending to electrical complaints from Township residents such as switch fault, ceiling fans, earth leak, no electric supply, electric shock, maintaining office for fuse of call, etc., maintenance of street lights, providing rewiring or new wiring for internal electrification, service connection for residential and non-residential buildings in all Township (Kailasapuram, Kamarajapuram & Nehru Nagar), operation & maintenance of electrical installations like electrical gadgets, DG sets with connected control panel and other accessories, automatic control panels, etc., at Main Hospital, RSK Dispensary, Equalising Reservoir Complex, Head works at Vengur, Puthapuram, Keelamullaikkudi, etc., of BHEL, Trichy.
