# 3. Project Background & Objective

Bidders, whose bids are responsive, based on minimum qualification criteria / documents as in Pre-Qualification Criteria and score at least Eighty (80) marks in the (given) defined scoring mechanism would be considered technically qualified. ### 4.3 Commercial Evaluation

All technically qualified bidders will have to submit an undertaking for "Acceptance of Technical Evaluation done by BHEL".

Any extension of bid validity as desired by BHEL shall be complied with forthwith without any demur and/or delay by the technically qualified bidders.

The technically qualified Bidders will participate in the reverse auction/conventional price bid opening process, as the case may be, as per BHEL's decision. In case of Reverse auction, BHEL will inform all qualified Bidders about Reverse Auction & the multiplication factor applicable to that bidder in order to arrive at destination cost or Cost to BHEL. The successful bid in the reverse auction will be the one with lowest destination cost or cost to BHEL. BHEL reserves the right to negotiate with the lowest bidder.

BHEL's Reverse Auction guidelines are as per Annexure IV.

# 5. Scope of Work

#### 5.1 Overview

BHEL intends to implement an Enterprise Social Network (ESN) Solution on an Open Source Framework within the timeframe indicated in this document. The Solution would encompass Design, Configuration, Development, Implementation and Maintenance of ESN solution as well as interface & integrate with BHEL's relevant legacy applications and would cover the Functional, Technical, Geographical, & detailed scope mentioned in the following sections. The solution would include the underlying database and all the other supporting Software.

The bidder, while responding to the scope of work (as per Functional & Technical scope) of this RFP document via various formats for Technical & Price Bids etc. must ensure that all necessary Software, Licenses, Implementation effort, Annual Technical Support, Support & maintenance, Integration Tools/software, etc. for creating and sustaining the entire Solution



have been factored suitably. Any additional cost, not factored suitably in the response, but necessary for completeness of the Integrated Solution shall be solely borne by the Bidder.

The ESN website should be designed with a view to giving maximum exposure to content and design. The site will display the full range of BHEL activities and functions. The website design, development and testing stages ensure that the website is compliant with International accessibility standards, best practices and security standards. The website contents will be developed and made available in English but Hindi capability should be available. The hardware and hosting of the website will be provided by BHEL.

The website should have Look and feel with aesthetics design, good color combination, background and screens, structure and layout, easy navigation facility. The Website should be developed using Free and Open Source Software (FOSS) solutions for platform independence using the specific Content Management Software and web analytics on all Operating System, along with following features:

- 1) Authentication through employee's staff number
- 2) My Profile: Personal profile with rich information- capabilities, interest, picture
- 3) Post messages
- 4) Comment: text form to add comments on published content by another user
- 5) Reply to already posted messages
- 6) Hyperlinks: Put in message body and its display in snippets
- 7) Referencing: Link of user profile (display as name) within messages
- 8) Social feedback: 'like' button
- 9) User wall: Display of messages
- 10) Forums: Messages will be categorized based on pre-defined topics (with categorization)
- 11) Engage end users: Polls, Quizzes, Surveys
- 12) Search (user, message, content etc.)
- 13) Help! My BHEL Answers: Knowledge sharing; based on Yahoo answers l
- 14) News feed: BHEL news feeds from all establishments
- 15) My Network: Pre-defined groups solely for collaboration purpose (post in these groups will be privy to group members only)
- 16) One level of moderation for all content

#### **5.3 Technical Requirements**

The technical requirement of the website platform mentioned below:

- 1) Operating System (OS), Data Base, Web Service, Web development language, Screen Designing: On Open Source Platform.
- 2) The solution should be scalable w.r.t. handling capacity of around 20000 users and concurrency of 15-20%.
- 3) The entire website with portal capabilities should be based on Web 2.0 and robust CMS based technologies.
- 4) Disaster Recovery (DR) and Business Continuity Plan (BCP): A detailed DR/BCP for the Website services should be submitted as a part of the proposal.
- 5) The desired navigation structure, general functionalities and reference points for the design will be discussed with the successful Bidder prior to start of work. In this context, BHEL will also be open to design & development suggestions from the successful Bidder.
- 6) The website will be based on popular open source Content Management System (CMS) like Joomla, Drupal etc.
- 7) Three theme-based template prototypes will be developed by the Solution Provider for the chosen CMS having the flexibility to change color / font / menu themes. One of the prototypes will be finalized by BHEL for Actual Development and deployment.
- 8) The site design must be cross-browser and cross-OS compatible up to the most recent browser (Internet Explorer, Chrome, Firefox etc.) / OS versions (Windows 7 and up, Linux).
- 9) Support for three platforms: Desktop/Tablet or Notebook and Mobile form factors.
- 10) W3C standard.
- 11) Weightage will be given to capabilities in templating, theme-design and security capabilities of the bidder.
- 12) Feedback form with integration of e-Mail to respective area.
- 13) Feature of email which is involving sending automated replies, tracking, reporting and download Statistics etc.
- 14) The website should incorporate necessary security features against hacking and defacement. All logins and payments transaction must operate on secure protocols. It should provide support for website security audit. BHEL conducts periodic VA (Vulnerability Analysis) & PT (Penetration Testing) for websites internally or through third party. Bidder's scope of work includes incorporation of corrective and preventive actions as and when identified in such testing/audits.
- 15) The portal should comply fully with the guidelines issued from time to time by the Government of India for development of websites.
- 16) The application should be responsive and browser compatible.
- 17) Data must be stored in optimized manner in the scalable database. Database used should also be popular open source database.
- 18) Web portal should have session management capabilities.
- 19) Should have role based authentication and functionalities.
- 20) Should have user management, roles and rights management module for administrator.
- 21) Should have application based backup and restore facility including integration of Third party backup and restore facility
- 22) Repository of the database must be maintained within the database along with the data description
- 23) The application must be platform independent
- 24) Data entry screens must have the provision of saving the draft data
- 25) Provide application development tools to support the continuous development/refinement of applications.
- 26) Provide interactive validation of data entry by users.
- 27) The portal should have a feature to interact by the way of email and SMS.



- 28) The necessary and already available data should be pre populated into the entry forms to reduce the entry work and this will also increase the consistency of the data.
- 29) A mobile app (Android, windows and iOS) for the web portal with complete functionality should be made available.
- 30) All the suggestions in the due course of time should be incorporated into the CMS based web portal until made Go Live. The changes after Go-Live will come under Change Management process and will be taken care by the bidder as per the contract agreement.
- 31) It should have provision of proper logs & audit trails.
- 32) Excel spreadsheet upload with data extraction to database and applicable metadata.

## 5.4 Data Migration & Integration

BHEL has a centralized SAP-HCM implemented for all employees. The basic data of employees for ESN application shall be imported by the successful Bidder one-time from SAP-HCM database. Subsequently, any changes in the SAP-HCM database w.r.t. transfers, retirement, resignation etc. have to be replicated in ESN with not later than a day's gap. Successful Bidder has to make necessary provisions in ESN for the same. Any effort required in SAP-HCM platform shall be done by BHEL in consultation with the Bidder.

Using SSO (Single Sign ON), the bidder shall integrate ESN with other BHEL applications. Such integration would only be w.r.t. Sign In to the other application from ESN. Further, the authorizations of each application shall continue as it is. Any effort required in other applications shall be done by BHEL in consultation with the Bidder. The list of applications to be integrated via single Sign-On shall be finalized during project design phase.

#### 5.5 Training

Proposals should include comprehensive training to BHEL's technical staff (IT) on configuration, audit reports, and management of the site. The team member responsible for training department managers on using the new site should be included in the proposal. A proper KT (knowledge transfer) shall be conducted by the bidder before sign off the project completion and application Go-Live.

## 5.6 Maintenance

Bidder shall provide a period of 90 days bug free support after the website gets LIVE and needs to take care of any bugs or issues caused during this duration.

The entire ESN platform go-live time is Ten (10) weeks from the date of signing of Contract between BHEL & successful bidder, act

In case Bidder plans to deploy onsite team for the project, BHEL will provide necessary seating space and connectivity to the Bidder's personnel. Any travel, boarding or lodging arrangements for the Bidder's personnel travelling to BHEL's location i.e. Delhi(NCR), shall be borne by the Bidder.

#### 11. Special Terms and Conditions

#### 11.1 Penalty for late submission of Security Deposit:

If security deposit is not submitted within 15 days from the date of order placement, an amount equivalent to interest calculated on the basis of interest rate equal to the prime lending rate of SBI plus 1% will be deducted from the quarterly bills.

# 11.2 Delivery Period:

Delivery period shall be 6 (Six) months (till completion of maintenance as per section 5.6) from the date of placement of Purchase Order by BHEL on the successful Bidder.

#### 11.3 **Rates:**

# 11.5 Payment Terms:

## 11.10 Penalty for late Delivery

If the Bidder fails to maintain the required progress of work which results in delay in the completion of the work as per the contractual completion period, BHEL shall have the right to impose Liquidated Damage/Penalty at the rate of 0.5% of the contract value, per week of delay or part thereof subject to a maximum of 10% of the contract value. # 12. General Terms and Conditions

#### 12.1 Ethical Standard:

# 12.6 Bid Opening

  - 12.15.3.4 Securities available from Post Offices such as National Savings Certificates, Kisan Vikas Patras etc. (Certificates should be held in the name of Contractor furnishing the security and duly pledged in favour of BHEL and discharged on the back).
  - 12.15.3.5 Bank Guarantee from Scheduled Banks / Public Financial Institutions as defined in the Companies Act.
  - 12.15.3.6 Fixed Deposit Receipt issued by Scheduled Banks / Public Financial Institutions as defined in the Companies Act. The FDR should be in the name of the contractor, A/C BHEL, duly discharged on the back.
  - 12.15.3.7 Security deposit can also be recovered at the rate of 10% from the running bills. However in such cases at least 50% of the Security Deposit should be deposited in any form as prescribed before start of the work and the balance 50% may be recovered from the running bills.
  - 12.15.3.8 EMD of the successful bidder can be converted and adjusted against the cash portion of Security Deposit excepting for such bidders who have remitted One Time EMD.

- 12.15.5 The validity of Bank Guarantees towards Security Deposit shall be initially up to the completion period as stipulated in the Letter of Intent/Award + 3 months, and the same shall be kept valid by proper renewal till the acceptance of Final Bills of the Contractor, by BHEL.
- 12.15.6 BHEL reserves the right of forfeiture of Security Deposit in addition to other claims and penalties in the event of the Contractor's failure to fulfil any of the contractual obligations or in the event of termination of contract as per terms and conditions of contract. BHEL reserves the right to set off the Security Deposit against any claims of other contracts with BHEL.

# 12.16 Return of Security Deposit:

Security Deposit shall be refunded/Bank Guarantee(s) released to the Contractor after deducting all expenses / other amounts due to BHEL under the contract / other contracts entered into with them by BHEL.

# 12.17 Purchaser's Right to accept or Reject any or all Bids:

The Purchaser reserves the right to make changes within the scope of the Contract at any point of time.

- 12.17.1 The Purchaser reserves the right to accept or reject any or all bids, and to annul the Tender process at any time prior to the issue of Letter of Award. In this case, the Purchaser shall not incur any liability to the affected Bidders or any obligation to inform the affected Bidders about reasons for such action.
- 12.17.2 The Bidder shall not sub-contract supply of software/licenses without written consent from BHEL. Further, BHEL shall not be liable for making any payments to the sub-bidders.

# 12.18 Statutory Obligations:

All statutory obligations arising out of this contract (like Insurance, PF, etc. of man power deployed by the bidder) shall rest with the successful bidder.

#### 12.19 Liabilities from the Contract

Any liabilities arising out of this contract (like injury, fatal/non-fatal, to the personnel of the successful bidder or any third party/contractor employed by the bidder) shall be to the successful bidder's account only. BHEL shall not be liable in any such eventuality.

#### 12.20 Non-Disclosure Agreement:

- 12.20.1 The successful bidder shall comply with the Information Security Management System of BHEL and work within the framework of ISMS as applicable in BHEL from time to time.
- 12.20.2 All the material / information sent to the successful bidder shall be treated as confidential and should not be disclosed in any matter to any unauthorized person under any circumstances. The successful bidder has to furnish a Non- Disclosure Agreement (NDA) as per Annexure-IV in line with the owner's Information Security Management System (ISMS).



#### 12.21 Risk Purchase:

Purchaser shall reserve the right to terminate the order / contract and purchase from elsewhere at the risk and cost of the Vendor, either the whole or part of the Systems / goods, which the Vendor has failed to deliver within the stipulated delivery period or if the same were not available, the best and the nearest available substitute(s) thereof. The Vendor would be liable to compensate the Purchaser for any loss and overheads, which the Purchaser may sustain by reason of such purchase. This clause will be operated only after completion of delivery period including extended period with penalty.

#### 12.22 Arbitration:

In all cases of disputes emanating from and in reference to this contract, the matter shall be referred to the arbitration. All disputes or differences between the parties will be resolved through arbitration governed by "The Arbitration and Conciliation Act, 1996" as amended from time to time. The venue of arbitration shall be in New Delhi. However, till the time the decision of the arbitrator is not announced, the Bidder/Vendor shall continue to provide its services to BHEL as per the contract.

# 12.23 Laws Governing the Contract:

The order/ contract shall be executed and governed by the laws of India and the courts of India alone shall have jurisdiction in respect of any matter arising under or in connection with the order/ contract.

Courts at Delhi/ New Delhi shall have exclusive jurisdiction to decide the dispute, if any, arising out of or in respect of the contract to which these conditions are applicable.

# 12.24 Merger & Acquisition:

In case of mergers and acquisitions of the bidder company or the OEM, all the contractual conditions and obligations shall automatically get transferred to acquiring company / entity and acquiring company must assume all the obligations of the contract till the end of the contract period.

# 12.25 Bankruptcy:

If the Bidder becomes bankrupt or have a receiving order made against him or compound with his creditors or being a Corporation commence to be wound up, not being a voluntary winding up for the purpose only or amalgamation or reconstruction, or carry on their business under a receiver for the benefit of their creditors or any of them, BHEL shall be at liberty:

- 12.25.1 To terminate the engagement forthwith without any notice in writing to the Bidder or to the liquidator or receiver or to any person in whom the Bidder may become vested.
- 12.25.2 To give such liquidator or receiver or other person the option of carrying out the engagement subject to their providing a guarantee for the due and faithful performance of the engagement up to an amount to be determined by BHEL.

# 12.26 Force Majeure:

Vendor shall not be responsible for delay in delivery resulting from acts / events beyond his control, provided notice of the happening of any such act / event is given by the Vendor to the Purchaser within 15 days from the date of its occurrence. Such acts / events shall include but not be limited to acts of God, war, floods, earthquakes, strikes, lockouts, epidemics, riots, fire or Governmental regulations superimposed after the date of order / contract.



## 12.27 Indemnity:

Vendor/Lessor shall fully indemnify and keep indemnified the Purchaser/Lessee against all claims which may be made in respect of the use of System / Software / Item(s) / services supplied / rendered by the Vendor / Lessor, for infringement of any rights protected by patent, registration of designs or trademarks and legality of the Software. However, the Vendor/ Lessor will have no obligation for any claim of infringement arising from third party products not supplied in the order, modifications and technical information/ instructions advised by purchaser and use of products prohibited by product manuals.

All such claims in this regard will be settled as per Indian Laws.

In the event of any such claims being made against the Purchaser/Lessee, Purchaser/Lessee will inform in writing to the Vendor/Lessor who shall at his own risk and cost either settle any such dispute or conduct any litigation that may arise there from.

## 12.28 Limitation of Liability:

The vendor's liability shall be limited to the value of this contract only.

# 12.29 Exemption:

MSMEs, registered with District Industries Centers or Khadi and Village Industries Commission or Khadi and Village Industries Board or Coir Board or National Small Industries Corporation or Directorate of Handicrafts and Handloom or any other body specified by Ministry of Micro, are exempted from payment of cost of tender document and EMD as well as entitled to avail the benefit of **Public Procurement Policy for Micro and Small Enterprises (MSEs), dated 23.03.2012**, subject to furnishing the documentary proof in support of claim along with their request letters and feasibility in terms of ordering and supply.

# 12.30 Termination of Contract & its Consequences:

- 12.30.1 Purchaser reserves the right to terminate the order/contract, either wholly or in part, upon situations arising due to non-compliance of stipulations of the Order/contract by the Vendor.
- 12.30.2 Vendor shall continue the performance of the order/contract under all circumstances, to the extent not cancelled.
- 12.30.3 BHEL reserves the rights to cancel the contract in case the services are not found to be satisfactory.
- 12.30.4 BHEL will give one month notice to the vendor before canceling/terminating the contract.

#### 12.31 Acceptance of Order:

Letter of acceptance of the Order along with Security Deposit (as per clause 12.15) is to be submitted within One week of receipt of Order.

  - 5.2. Is or becomes publicly known through no wrongful act of the Recipient, its employees, officers, directors, or agents; or
  - 5.3. Is independently developed by the Recipient without reference to any Confidential Information disclosed hereunder; or
  - 5.4. Is approved for release (and only to the extent so approved) by the disclosing Party; or
