- 3.0 Your offer & documents submitted with the offer shall be signed & stamped in each page by your authorised representative. No overwriting/ correction in tender documents by bidders shall be allowed. However, if correction is unavoidable, the same may be signed by authorized signatory.
- 4.0 All documents/ annexures submitted with the offer shall be properly annexed and placed in respective places of the offer as per enclosure list mentioned in the covering letter. BHEL shall not be responsible for any missing documents.
- 5.0 No Deviation with respect to tender clauses and no additional clauses/ suggestions/ clarification shall normally be considered by BHEL. Bidders are requested to positively comply with the same. Offers with deviation are liable for rejection.

SCOPE & SPECIAL TERMS AND CONDITIONS OF THE CONTRACT

Following are the scope, special terms and conditions of the contract.

- 1.0) NAME OF THE WORK**
Supply of vehicle on hiring basis for used of BHEL MSTPP Project works.
- 2.0) SCOPE OF WORK:**
Areas: As per Reporting instruction by the authorized Officer/Engineer of BHEL to report the vehicle. It may be at Project Site, Khulna, Jessore Airport, Bhomra Border, Benapole Border, Mawa Ghat or any other location as per the requirement of the BHEL.
Job Details: As per details given below: -
 - a) Providing different types of Vehicle on Monthly, Daily Basis or only pick up and drop from fixed places as per the requirement of BHEL.**
 - b) Providing different vehicle to pick and drop to prominent location like land border, Jessore Airport, ferry Ghat etc.**
 - c) Vehicle must be in Good conditions.**
- 3.0) Immediate requirement of the Vehicle is given in Annexure – 3. Other vehicle will be order from time to time as per the requirement during the validity of the price bid and the price shall remain valid for 24 months for the L1 bidder against each vehicle.**
- 4.0) L1 against each vehicle will be decided separately.**
- 5.0) Bidder should ensure that they will be able to provide vehicle on casual basis (Daily or Pick up Drop) in a short notice of 12 hours and monthly basis in a notice of 3 days and in case of failure for 3 times their contract will be liable to terminate without any notice and vehicle arranged by BHEL shall be recovered from their pending bill with 30% overhead.**
- 6.0) It is not mandatory to provide price for all the vehicle in Vol –III. Bidder should quote the price only for the vehicle which they will be able to provide.**
- 7.0) The contractor shall comply with all statutory rules, regulations etc. as applicable.**
- 8.0) The contractor shall pay all taxes fees, license charges deposit duties, royalty commissions or other charges which may be levied on account of his operation in executing the contract to the concerned authorities. In case BHEL is forced to pay any of such taxes / charges, BHEL shall have the right to recover the same from the contractor either from his bill or otherwise as deemed fit.**
- 9.0) The contractor shall be responsible for the proper behavior at the place of work and observance of all regulations by the staff employed by him.**
- 10.0) The contractor shall ensure that no damage is caused to any person, property of other parties working at the place of work. If any such damage is caused, it is the responsibility of the contractor to make good the losses or to compensate for the same.**
- 11.0) All safety rules and codes applied by BHEL at the place of work shall be observed by the contractor without exception. The contractor shall be responsible for the safety of the cars / vehicles and work to be performed by him and shall maintain all protection necessary for the purpose. The contractor shall also take precaution as may be indicated from time to time by BHEL with a view to prevent pilferage, accidents, fire hazard/hijack of car, vehicle, driver etc and due precaution shall be taken against fore seen or unseen hazards and atmospheric conditions.**
- 12.0) The contractor shall be responsible to arrange Gate Pass of vehicle and driver and its timely renewal.**
- 13.0) The contractor shall be directly responsible for payment of wages to his workmen/driver/s by 7th of the following month. If there is any delay in submission & settlement of bill due to any reason whatsoever, payment must not be delayed beyond 7th.**
- 14.0) The bidder must have his own /telephone and mobile facilities so that he can be contacted as and when necessary.**
- 15.0) The drivers must be provided with a working mobile phone. If the owner fails to provide mobile phone a sum of BDT. 500/- will be deducted from the monthly bill. If the driver keeps the mobile switched off or does not attend call a penal charge @ BDT 500 per day will be recovered.**
- 16.0) Shall maintain our logbook for recording relevant details and must be in possession of valid driving license of commercial cars as well as be able to do minor repairs of cars and attend to break downs. Also, he should have experience in driving on highways.**

- 17.0) Drivers of such car (s) must be smart, neatly dressed with the uniforms and shoes to be provided by the contractor at his own cost. The driver provided by the contractor, of the said car(s) should not be engaged for any other job during the tenancy of this contract.
- 18.0) Car parking fees for official duties will be reimbursed on monthly basis on production of valid parking slips / vouchers and certified by concerned authority.
- 19.0) Total car maintenance of whatever nature, repair charges and other expenses towards consumables like Mobil/gear oil etc. in respect of the cars are to be fully incurred and borne by the contractor. Expenditure in connection with the replacement of the spare parts, accessories, fittings, tyres tubes, upholstery etc. and other items of the car(s) are to be incurred and borne exclusively by the contractor. No payment will be made by BHEL for this purpose. Car at the time of reporting should be in tiptop cleaned condition.
- 20.0) If the contractor fails to maintain and repair the cars properly including replacement of various fittings, fixtures spare parts, accessories, tyres upholstery etc. BHEL reserves the right to get the car(s) maintained and repaired at the risk and cost of the contract and the cost incurred thereto along with 30% overhead charges will be deducted from the bills. 01 (one) No. spare type (stepney) in good running condition should be kept in vehicle at all times. All four Wheels must be in good condition and resoling tyre cannot be used.
- 21.0) In case of breakdown of vehicle/s, replacement will be made by the contractor within 02 (Two) hours from the reported time of breakdown.
- 22.0) In case of failure to supply any car(s) / vehicle/s on any day, or withdrawal of car / vehicle due to breakdown or other reasons, deduction on pro-rata basis will be made from the bills of the contractor. Further, in case of failure of supply replacement car(s) from any other source, an additional 30% of the contract rate per day shall be imposed as penalty. If BHEL has to engage vehicle from market the actual hire charge plus 30% Overhead Charges will be deducted from the bill.
- 23.0) All legal statutory and financial requirements and liabilities whatsoever in connection with the car(s) to be supplied to BHEL are to be complied with by the contractor. All payments relating to Registration, Permit, Road-Tax Comprehensive Insurance etc. and other related expenditure are to be incurred and borne by the contractor. The contractor shall comply with the provisions of the Motor Vehicles Act and other relevant laws as may be applicable from time to time in respect of his contract with BHEL.
- 24.0) The car (s) will be required to be properly maintained and serviced regularly by the contractor at his own cost.
- 25.0) The car(s) will be required to ply within any part of Bangladesh.
- 26.0) The contractor shall maintain sufficient funds with the chauffeurs to meet any emergency requirement on account of fuel, parking fees, emergency maintenance etc.
- 27.0) The following accessories/safety devices are to be installed/ provided compulsorily in the car taken on hire, both monthly and on casual basis as per the prevailing rules in this regard.
- a) Seat belts
 - b) First Aid Box (with minimum facilities as prescribed by a medical practitioner)
 - c) One No. Stepney in working condition in the vehicle.
 - d) Necessary Tool kit.
- 28.0) Mileage meter (Km indicator meter) reading should be sealed and in properly working condition/sealed. If km indicator of any car is found tampered at any point of time, BHEL reserves the right to reject/terminate the party without any notice.
- 29.0) The bidder shall enclose the details of the vehicle to be supplied by him, clearly specifying the registration no. of the vehicle and the date of registration accompanied by documentary proof along with his offer. The bidder may be required to make vehicle available at this BHEL office for inspection by BHEL for the purpose of assessing its suitability.
- 30.0) **In general, the vehicle will be required at Maitree Site Premises for movement in site and local market and may be sent to other location as per requirement of M/s BHEL. So, contractor shall arrange the accommodation of their driver if required and no separate payment will be made for the same.**
- 31.0) BHEL will carry periodic checks on the vehicle and the contractor shall be given reasonable time to rectify the defects, if any, found during the such checks. The check details shall be recorded in a separate paper for suitable necessary action by the contractor.
- 32.0) The successful bidder should furnish the Comprehensive Insurance Policy including third party liability. He shall also get it renewed periodically.

- 33.0) The bidder to ensure filling of fuel (Diesel/Petrol/Gas) for daily requirement shall arrange necessary, for the vehicle. Other than hiring charges, parking & tolls fees, would be paid by BHEL on producing of original bill on monthly basis only.
- 34.0) Decision of BHEL will be final in this regard to award the contract at respective lowest rate of the party.
- 35.0) The quoted rates shall remain firm throughout the contract period. No compensation/escalation shall be payable by BHEL during the period.
- 36.0) The vehicle with driver should always be ready to perform any emergency duty at any point of time.

37.0) INSURANCE:

37.1) It is the sole responsibility of the contractor to insure his car/vehicle/driver against injury, disability and death while at work and to pay compensation to his driver, if so happened. The contractor shall have to take a Workmen's Compensation Insurance Policy / Cover against claims for injury, disability, disease, death etc. to his staff. The liability shall not be less than the provisions of the Workmen's Compensation Act.

37.2) If due to negligence and / or non-observance of the safety and other precaution any accident / injury takes place to any person(s)/public, the contractor shall have to pay necessary compensation and other expenses, if so, decided by the BHEL authorities.

- 38.0) Contractor's employees on duty shall maintain proper records/documents/log sheet as per requirement of the company in connection with above services.
- 39.0) Contractor's employees on duty shall bring to the notice of designated officer of BHEL any untoward occurrence/incidents in the premises.
- 40.0) Accommodation of personnel under this contract shall be arranged by the contractor at their own cost and no house rent allowance will be paid against the same.
- 41.0) **All Daily rated vehicle and Pick-up drop vehicle must have neat and clean towel on seat, Sealed Drinking Water Bottle (2 Bottle), Driver must have uniform/aesthetic dress.**

42.0) VALIDITY

- 42.1) This contract will initially be for a period of two years from the date of commencement of acceptance of the contract. This contract is renewable depending on the necessity on the existing rates, terms and conditions and subject to satisfactory service at site.
