

**PRE – QUALIFICATION CRITERIA**

- 1) Bidder should submit a COPY OF PAN CARD
- 2) Bidder should submit an AUDITED COPY OF IT RETURN FOR LAST THREE YEARS (2012 – 2013, 2013 – 2014, 2014 – 2015).
- 3) Bidder should submit a COPY OF IBA APPROVAL WITH REGISTRATION CERTIFICATE WITH ITS VALIDITY.
- 4) Bidder should submit a LIST OF BRANCHES ALL OVER INDIA WITH HEAD OFFICE & IT'S FULL ADDRESS TELEPHONE NUMBERS MAIL ID AND CELL NUMBERS OF PERSON
- 5) Bidder should submit a LIST OF FIRMS FOR WHOM YOUR FIRM HAS WORKED, ENTERED INTO CONTRACT DURING LAST TWO YEARS. (With documents)
- 6) Bidder should submit a LIST OF TRUCKS/TRAILORS OWNED BY TRANSPORTER WITH THEIR REGISTRATION NUMBER.
