1.00 GENERAL INFORMATION

The Company is desirous of procuring Glucose Biscuit weighing 25 to 40 grams. per pack from the biscuit manufacturers for its canteen at BHEL Ranipet, Vellore District. Tamil Nadu.

2.00. Eligibility Criteria (Mandatory)

- 2.01 The manufacturer should have experience in biscuit manufacturing for a minimum period of 5 (Five) years and supplying biscuits to the need of minimum of 500 persons per day with an average annual turnover of Rs. 500 lakhs per annum for the last 2 years. Documentary evidence and clients list shall be submitted.
- 2.02 The Weight of the Glucose Biscuit is 25 to 40 grams. per packet. In case the weight is more than 40 gms. the weight will be restricted to 40 gms. only. Less than 25 gms. will not be considered.

Other Conditions

- 2.03 Audited balance sheet and P&L account for the past two preceding financial Years shall be furnished.
- 2.04 BHEL reserves the right to reject any or all the bids at any time without assigning any reason whatsoever. The opinion / decision of BHEL regarding the acceptance or rejection of the bid shall be final and conclusive.

3.00 Scope of work

- 3.01 As per our present requirement, the biscuit shall be supplied twice in a week. Monday, Thursday between 9.00 AM & 12.00 Noon. The above schedule is only indicative and BHEL has the right to increase the delivery frequency for more than thrice a week. No extra charges will be paid for the increase in delivery schedule.
- 3.02 Scope of the work includes transportation, labour charges for delivery at our canteen as above.
- 3.03 In brief, the vendor or his authorized Agent, shall bring the biscuit and deliver at our canteen.
- 3.04 Approximately 10,150 biscuit packets per week will be required. However, the exact quantity requirement will be intimated in advance. The quantity is only indicative and may vary.

4.00 PERIOD OF CONTRACT

The contract shall be for a period of 12 months in the first instance from the date of actual award of the contract. On satisfactory performance, the contract may be extended at the discretion of BHEL for further period at the same rates, terms and conditions of the contract subject to mutual consent.

5.00 RISK PURCHASE CLAUSE

5.01 During the currency of this contract or during its extended period, if the contractor fails to supply the biscuits as per the terms and conditions of this contract, it will entail BHEL to make alternative arrangements for the supply of biscuit packet mentioned under the scope of work, through any other agency and the extra cost incurred thereon shall be recoverable from the contractor's bills. The decision of the management with regard to recoveries referred to shall be final and binding on the contractor.

6.00 TERMS AND CONDITIONS

- 6.01 The biscuit shall be of good quality ie. Tasty, crisp and hygienic. The biscuits shall be packed in 'Air-Tight' pack.
- 6.02 Only good quality ingredients shall be used for the preparation of biscuit.
- 6.03 Any biscuit packet not found suitable for consumption, in the opinion of the canteen personnel, will be rejected and no payment will be made for that particular item.
- 6.04 The supplier shall bring in his own vehicle, crates and labour.
- 6.05 The biscuit packets shall be delivered at BHEL canteen at the cost of the supplier.
- 6.06 The biscuit packets shall be brought with proper delivery challan in triplicate. The original invoice shall be presented to our Security Staff at the East gate for inward permission. The biscuit packets will be counted / weighed by BHEL staff in our canteen. Only the quantity received and accepted will qualify for payment.
- 6.07 The rate quoted shall be inclusive of transportation, unloading labour charges, but exclusive of taxes. Rates for the Tender schedule shall be quoted in rupees only.
- 6.08 Each pack must have manufacturing date, expiry date, weight etc.

7.00 RATE EVALUATION METHOD:

The quoted rate will be evaluated on 'per gram' basis for comparison purpose.

8.00 TERMS OF PAYMENT

- 8.01 The supplier shall present the bills in quadruplicate for the supply of the biscuit packets once in a month, to the Officer-in-charge of Canteen/HR, for processing the bills for payment. The bills shall be submitted along with the Delivery Challan duly signed by the supplier.
- 8.02 Payment will be made for the bills submitted by the contractor after due verification.
- 8.03 Payment will be made against actual quantity supplied ie number of packets.
- 8.04 Payment will be made within 30 days from the date of receipt of the bill through Account Payee Cheque only or EFT at the discretion of BHEL.
