**SCOPE OF WORK AND TERMS & CONDITIONS**

**For Hiring TATA INDICA DIESEL (Non-AC) Taxi (1 No.) on Monthly Rental Basis**

1. Sealed Tenders for the above noted work are hereby invited from Contractors operating in and around Marathahally/Doddanekkundi Outer Ring Road/Krishnarajapuram/Jeevan Bhimanagar/Airport Road/Thippasandra areas.
2. The offer should be submitted in **Two** parts (part-1 & 2) as follows in separate sealed envelopes.
  - a) Technical and Commercial Bid . part-1, Page 2 to 11 including essential criteria for techno-commercial evaluation (To be superscribed on the envelope as **%Technical & Commercial Bid+**). Demand draft for Rs.10000/= towards Earnest Money Deposit (EMD) shall be enclosed with Technical & Commercial Bid . Part-1. Offers without EMD are liable to be rejected.
  - b) Price Bid . part-2, page 12 (To be super scribed on the envelope as **%Price Bid+**).

The above two separate sealed envelopes are to be put into a single sealed envelope and super scribed with tender reference and tender opening date.  
**The technical & commercial bid should not include prices.**

3. Non-AC diesel Tata Indica taxi (**Year of Regn. 2007 / 2008**) along with drivers should be supplied.
4. Vehicle should be maintained in good and smooth running condition through out the period of contract.
5. Car should be totally dedicated for use by BHEL/ISG Senior Official residing at Fern Paradise, Outer Ring Road, Doddanekkundi, Near Marathahally and should not be used by anybody for any other purpose.
6. Vehicle will be used for local trips only (within 80 km radius from the Office situated at Malleswaram, Bangalore-560012.
7. Taxi is to be provided on all days including Sundays and holidays. Normal hours from 6.0 AM to 10.00 PM on all days of the month including Sundays and holidays for a maximum of 12 hours on any day. However if the hours exceeds 12 hours per day charges for extra hours for more than 12 hours per day will be paid and the charges per hour for more than 12 hours per day has

to be quoted in the price bid. Driver batta will be paid if taxi is used beyond 10.00 PM on any day and the batta rate has to be quoted in the price bid. To be eligible for batta the journey shall end later than 11.00 PM.

8. The diesel Tata Indica (non-AC) each will be used for a maximum of 3000 kms. Per month cumulative. However if the kilometers exceeds 3000 kms cumulative per month charges for extra km beyond 3000km will be paid and the charges for the same have to be quoted in the price bid.
9. Rates quoted shall be valid for a period of one year from the date of entering into contract. However the rate is subject to Price Variation clause (PVC) as given in Cl.32. The rates shall be quoted in the **Price Bid** enclosed.
10. BHEL/ISG reserves the right to extend the validity period of contract for a further period of one more year at the same rates, terms and conditions applicable to this contract, as mutually agreeable between BHEL and the contractor.
11. Deduction of cost of Diesel for unused kilometers (max: 500 km) will be arrived at a rate of mileage of 15 Kms/litre for Tata Indica car. It may be noted that the minimum assured distance coverage per month is 3000 KM.
12. Dead KM distance is allowed (for actual distance or 10 KM whichever is less) for conveyance of vehicle from contractor's office to Residence of Higher Official and back from Residence of Higher Official to contractor's office. In case the reporting/release point is other than Residence of Higher Official, distance from travels to reporting/releasing point at actual KM will be considered. The dead KM is a part of 3000 KM / month cumulative.
13. The contractor shall not sub-let any portion of the contract without prior written approval of the accepting officer.
14. The taxis shall report in full readiness for the entire day's operation in respect of fuel availability and willingness of the drivers.
15. The taxi will be utilized for Senior Executive who is to be treated well. The taxis should report to the required points as directed by HRM Dept. of BHEL/ISG well in time.
16. BHEL reserves the right to enter into contract with one or more transport contractors in addition / in lieu of this contract during the validity period of the contract.
17. Any addition, deletion or changes in the partnership deed should be informed to BHEL well in advance.

18. The contractor shall at his own expense reinstate and make good to the satisfaction of BHEL management and pay compensation for any injury, loss or damage occurred to any property or rights whatsoever including property and rights of BHEL (or agents), servants or employee of BHEL, the injury loss or damage arising out of or in any way in connection with the execution or performed execution of the contract and enforceable against BHEL where BHEL is a private person, in respect of any such injury (including injury resulting in death) loss or damage to any person whatsoever or property including all claims may arise under the Workmen's Compensation Act or otherwise.
19. The taxi shall be **2007 / 2008** model (registration year) at the start of the contract and should be maintained in good running condition and comfortable to the passengers.
20. The taxi drivers should wear white uniform and should have a working knowledge of Kannada, Hindi & English. They should keep the relevant **valid** documents (driving licence, road tax, registration certificate, insurance cover note, emission certificate, permit, etc.) with the taxi and produce as and when required by BHEL or any other inspecting authorities.
21. The contractor should also ensure that he / she will engage the vehicles with drivers who know the following genuine ethics and he / she will instruct to implement the same:
- a) The driver should have minimum three years experience of driving in similar vehicles with proof of valid driving license.*
  - b) The driver should keep the vehicle neat and clean daily / timely before reporting to the duty.*
  - c) The driver should allow the passenger to get inside the vehicle and later only he should enter into car.*
  - d) The driver himself should open and close doors for the Higher Official while getting into and getting out the vehicle.*
  - e) While on pick up from Railway station / Bus Stand / Airport, the driver should display the placard at the EXIT of the railway station / Bus stand / Airport or in the parking area as instructed by the User / HRM Dept.*
  - f) The driver shall not smoke / be drunk while on duty.*

22. The taxi should have covered all the provisions of Motor Vehicle Act, **1988** as in force from time to time, and fit for hire.
23. The payment will be made monthly after verification of bills with in 30 days from the date of submission of invoice for payment. Appropriate amount of TDS would be deducted as per IT Act. Applicable taxes to be quoted separately.
24. The actual taxi parking charges/toll charges incurred at airports / railway stations or any other places, will be reimbursed on production of actual receipt without any corrections or overwriting.
25. Trip sheets shall be filled properly mentioning places covered and obtain the user's signature.
26. The taxi driver shall have appropriate valid driving licence, and shall obey all traffic rules and safety precautions.
27. Misconduct of drivers will result in penalty, which may include the termination of contract.
28. Alternate arrangements shall be made immediately in case of problems like misplacement of vehicle or mechanical or any other problems encountered during journey, etc. The driver of the taxi shall have the responsibility and requisite authority to deal with such exigencies. Any financial implications as a consequence of such problems / alternate arrangement or any other action otherwise resorted to by BHEL/ISG shall be borne by the contractor.
29. A radius of 80 kilometers from the factory (within Karnataka State) will be considered as local trip.
30. The driver should be neat and tidy in white uniform during the working hours.

**31. PENALTY :**

- a) If the taxi is not supplied during the course of contract (on working days) due to taxi breakdown or any other reason the contractor has to supply alternate **Tata Indica** good taxi. If failed to supply alternate Tata Indica taxis penalty as given below will be imposed. However non-supply of taxi service will be viewed very seriously.

Penalty in Rs.= (Monthly rate per taxi in Rs./30) x 1.50

- b) During holidays and Sundays, if vehicle is required, prior information would be given and on the basis of which vehicle (Tata Indica taxi) along with driver should be arranged. Failure to do so will attract penalty as given below.

Penalty in Rs.= (Monthly rate per taxi in Rs./30) x 1.50

- c) After resuming duty, if the contractor does not ply the rest of the day or driver remain absent or driver refuses to attend duty for any reason, penalty as mentioned in point (a) above will be imposed.
- d) The essence of the contract being punctuality and regularity in providing courteous service to the users. Hence delay in reporting time will attract penalty of Rs.500/= for each instance.

**32. PRICE VARIATION:** In case of any change in the cost of fuel, hiring rate shall increase / decrease for every one rupee or part thereof per litre increase / decrease in the cost of fuel subject to documentary evidence. (If the changes in the fuel cost is effected in the middle of the month, then monthly rental will be computed proportionately for that month)

The changes will be as per the following rates.

Type of vehicle	PVC per KM per Rupee increase in fuel charge
Indica (Diesel) Non A/C taxi	07 paisa

No increase will be admissible on any other account.

- E.g. a) In case if there is increase in fuel price by one Rupee then,

*New monthly rental in Rs. = Existing monthly rental in Rs. + (3000 KM x 0.07)*  
*New rate per extra KM for beyond 3000 KM = Existing rate per extra KM in Rs. + 0.07*

- b) In case if there is decrease in fuel price by one Rupee then,

*New monthly rental = Existing monthly rental in Rs. - (3000 KM x 0.07)*  
*New rate per extra KM for beyond 3000 KM = Existing rate per extra KM in Rs. - 0.07*

33. The driver of the car should be provided with mobile phone for communication.

34. **ARBITRATION:** Any dispute arising out of this contract shall be referred to Head of HRM department. The decision of Head of HRM will be final and binding on all disputes on this contract.
