TERMS AND CONDITIONS OF THE TENDER SCHEDULE

SCOPE OF CONTRACT:-

The coal delivery order of M/s.SCCL will be handed over at Hyderabad to representative of the transporter. The transporter will co-ordinate with M/s.SCCL for taking delivery from the allotted location at Ramagundam / Godavarikhani/GDK-5/GDK-10/GDK-11A/ RK Puram (RK-7), Medipalli, Mandamarri, JVROC1 (Sathupally) etc. and arrange loading, transportation and unloading of the material from M/s. SCCL to M/s. B.H.E.L, Ramachandrapuram, Hyderabad-32 by Tippers. The present tender is for lifting of 12,000 MT of coal. The coal should be delivered at BHEL, Hyderabad within 1 (one) day from the day of lifting. In case of delay, penalty @ 2% of freight charges per day (of that vehicle) will be deducted from the freight bills, BHEL Holidays will not be counted for reckoning penalty. On an average a minimum of 500 MT is to be lifted per month (ie., 125 MT per week approx).

Terms and conditions:-

- 1. The tenderers should quote a total rate including all expenses including taxes and duties.
- 2. Tender Quote shall be valid for 90 days from the date of tender opening for finalisation.
- 3. The rates quoted shall remain FIRM for two years from the date of award of work.
- 4. EMD (Earnest Money Deposit) for Rs.2,00,000/- (Rupees Two lakhs only). The EMD shall be paid in form of Demand Draft in favour of BHEL, Hyderabad.
- 5. Quotations received without Earnest Money Deposit (in form of Demand Draft in favour of Accounts Officer BHEL Hyderabad in any Nationalised bank) will be rejected.
- 6. No interest on EMD will be paid by BHEL.
- 7. EMD furnished by the successful bidder will be adjusted as part security deposit towards contract performance guarantee and shall be refunded within three months of the date of expiry / completion / revocation of the contract. In the event of the agency failing to comply with any provision of the contract, the security deposit shall be forfeited by BHEL.
- 8. Successful tenderer shall pay a security deposit of 10% of the overall contract value for the period.

9. **SECURITY DEPOSIT:** Security Deposit should be collected from the successful tenderer. The rate of Security Deposit will be as below:

- b) Pay Order, Demand Draft in favour of BHEL.
- c) Local cheques of scheduled banks, subject to realization.
- i) Securities available from Post Offices such as National Savings Certificates, Kisan Vikas Patras etc.
 - (Certificates should be held in the name of Contractor furnishing the security and duly pledged in favour of BHEL and discharged on the back).
- ii) Bank Guarantee from Scheduled Banks / Public Financial Institutions as defined in the Companies Act subject to a maximum of 50% of the total security deposit value. The balance 50% has to be remitted either by cash or in the other form of security. The Bank Guarantee format should have the approval of BHEL.
- iii) Fixed Deposit Receipt issued by Scheduled Banks / Public Financial Institutions as defined in the Companies Act. The FDR should be in the name of the contractor, A/C BHEL, duly discharged on the back.
- iv) Security deposit can also be recovered at the rate of 10% from the running bills. However in such cases at least 50% of the Security Deposit should be collected before start of the work and the balance 50% may be recovered from the running bills.
- v) EMD of the successful tenderer shall be converted and adjusted against the security deposit.
- iv) The security deposit will not carry any interest and will be paid only after successful completion of contract to BHEL satisfaction.

The security Deposit should be collected before start of the work by the contractor.

- 10. BHEL reserve the right to cancel the contract in case of any breach or non compliance of any of the terms and conditions of the agreement, and enter into a parallel contract for the same work either entirely or for any period with one or more firms for getting the above work done and any extra expenditure involved in getting the above work done through other agencies, shall be recovered from the pending bills of the contractor.
- 11. Withdrawal of contract during the contract period will entail BHEL to encash security deposit, but also to appoint other transporter at the risk and cost of the contractor.
- 12. BHEL reserves the right to reject any offer or part of the offer without assigning any reasons.
- 13. BHEL reserves the right to terminate the contract either fully or partly without assigning any reasons.
- 14. The contract once finalized will be valid for TWO years from the date of awardal. BHEL has the right to cancel the contract in case of poor or bad service. The contract may also be extended based on requirement of BHEL management with same rates terms and conditions.
- 15. BHEL reserves the right to enter into a contract with more than one. The L1 rate will be counter offered to the next higher tenderer for acceptance. The contract will be shared by more than one transporter equally.
- 16. Freight payment will be based on the coal weighment at BHEL, Hyderabad. If the weight at BHEL, Hyderabad is less than load lifted, the difference in cost of coal will be adjusted with the transporter's bills.
- 17. Freight shall normally be paid the contractor by EFT (Electronic Fund Transfer) within 30 days from the date of presentation of Bill.
- 18. The tenderer should follow all statutory and environmental regulations.
- 19. Quoting of PAN No. has to be complied with under Section 139A of Income Tax Act.
- 20. Period of contract is for **TWO years** with effect from date of awardal of contract.

21. PRICE VARIATION CLAUSE: -

The freight rates finalised is subject to increase/decrease at the rate of 0.0003 paise per KG/KM for every 10 paise statutory increase/decrease in diesel price (inclusive Taxes applicable at Hyderabad of Indian Oil Corporation) over the prevailing price on the date of opening the price bid. The increase/decrease will be proportionate when the increase/decrease is less than 10 paise per liter.

The escalation shall be implemented from the date of revision announced by M/s.IOCL, Hyderabad.

(A) For purpose of calculation, distance from BHEL, R.C.Puram to various mines are as follows:

(B) The distances mentioned above are in accordance with the survey made by BHEL Hyderabad.

For any new mine, the distance shall be decided using "Google Search" only.

- 22. At the time of loading any expenses will be borne by the transporter only, BHEL is not responsible.
- 23. Transporter shall arrange their representative to guide the truck drivers for take vehicles inside the factory area, weighments, entries at stores and unloading etc., activities.
- 24. BHEL Security Rules and Regulations shall be followed strictly at J-Gate and inside the Factory Area.
- 25. That the transporter shall indemnify and compensate the BHEL for any loss or damage to the property of BHEL, occurred to transporter/his Drivers during unloading of materials. The loss or damage, as suffered by BHEL shall be adjusted from the security deposit, of the contractor or any sum due to him by the company.
- 26. Transport contractor to obtain insurance cover for his employees and equipment / tools / tackles / vehicles etc. and take third party risk insurance coverage at his own cost. BHEL will not be responsible for any loss, damage, pilferage of his property and / or his employees.
- 27. The transport contractor is directly responsible for injuries / death of vehicle driver or any person employed by him as well as to the third party occupants or other users arising due to accident or otherwise of vehicle during the contractual period. At any point of time, BHEL will not be responsible for any loss / damage either to the person or to the vehicle arising out of accident of the vehicle for performing the contractual obligations.
- 28. Any amount recoverable from transport contractor towards the loss / damage will be recovered from the outstanding payments due or from security deposit. In case the amount is insufficient for such recoveries, transport contractor shall make good the balance amount by remitting in the cash office at BHEL. The company reserves the right to enter into parallel contracts for the same period or any part thereof.
- 29. It is the responsibility of the transporter to bring the quantity loaded at SCCL without any shortage. For which necessary precaution is to be taken viz covering of tarpaulin with seal and the seal is to be removed at unloading point only. However unavoidable shortage if any will be recovered from the freight bill of such transporter as per Clause-16 above.

31. **SUB-LETTING OF WORK:**

Under no circumstances, the transporter after entering the rate contract would be permitted to arrange transportation of consignments entrusted to him through another transporter/agency i.e Subcontracting of the work either in full or in part is not allowed. However hiring of vehicles and services from other agencies/transporters is permitted.
