# SCOPE, TERMS AND CONDITIONS OF WORK

- 1. This contract is for a period of one year from the date of installation with all accessories and ingredients
- 2. Two Coffee Vending machines shall be positioned at BHEL EDN. The location within BHEL EDN will be as identified by the HRD representative from time to time.
- 3. The Vendor shall be responsible for transport of machine to BHEL-EDN and taking it out after contract period.
- 4. The machine shall be maintained, serviced and monitored by Vendor's operator.
- 5. Installation and maintenance of machine with all necessary accessories and support system is in vendor scope.
- 6. The ingredients shall be suitably (need base) supplied by vendor on regular basis and can be stored in BHEL EDN. Vendor operator will ensure utilization of these ingredients for making coffee, tea and other beverages.
- 7. BHEL EDN will provide only space for keeping machine, table for keeping machine, power point and storage space for storing ingredients.
- 8. Vendor shall use filter water (Not RO water) available within BHEL EDN. If RO water / bottled water is required for the machine, then the same as to be arranged by vendor without extra cost.
- 9. Estimated average beverage consumption will be 50 to 100 cups per working day per machine. However ingredients should be supplied on need base only after clearance from user ( HRD ). Minimum off take qty. of ingredients is not guaranteed.
- 10. Ingredients shall be supplied by you as per the agreed rates and bills shall be presented once in a month on the basis of actual consumption of ingredients.
- 11. Actual consumption of ingredients means " ingredients supplied on need base after clearance from user ( HRD ) ".
- 12. The quality and serving parameters shall be as per our requirement. We reserve the right to terminate the contract at any point of time on account of unsatisfactory service.
- 13. Mobilization and advance payment will not be made by BHEL.
- 14. All pages of offer should be signed by vendor.



# INSTRUCTIONS & GUIDELINES TO BIDDERS AND PRE- QUALIFICATION CRITERIA

# 1. INSTRUCTIONS & GUIDELINES TO BIDDERS (TENDERERS):

#### 1.1. BIDDER TO INFORM HIMSELF FULLY:

- a) The bidder shall closely peruse all the clauses, requirements etc., indicated in the tender documents, before quoting. Should the bidder have any doubt about the meaning of any portion of the tender specifications or find discrepancies or omissions in the specifications or if the tender documents are found to be incomplete or require clarifications on any of the technical aspects, scope of work etc. he shall at once contact the official inviting the tenders, for clarifications, before submission of the tender.
- b) Bidders are advised to study all the tender documents carefully. Any submission of tender by the bidder shall be deemed to have been done after careful study and examination of the tender documents and with the full understanding of the implications thereof.

#### 1.2. GOODS AND SERVICES TAX (GST):

- BHEL EDN GSTIN number is 29AAACB4146P1ZB. All invoices to contain BHEL-EDN GSTIN No.
- 2. The Tenderers shall furnish the GSTIN Registration Number in their offer (GSTIN copy of the same to be enclosed).
- 3. The changes in GST rates due to statutory amendment of GST Act during the course of contract will be paid as applicable.
- 4. If not registered under GST, undertaking to be submitted that contractor will register and furnish copy of certificate, before submitting the first bill.
- 5. The Bidder shall mention Bidder's GSTIN number in all quotations and Invoices submitted.
- 6. The Bidder shall also mention HSN (Harmonised System of Nomenclature) / SAC (Services Accounting Code) mandatorily in all quotations and invoices submitted.
- 7. Invoice submitted should be in the format as specified under GST Laws viz. all details as mentioned in Invoice Rules like GSTN registration number, invoice number, quantity, rate, value, taxes with nomenclature CGST, SGST, UGST,IGST mentioned separately, HSN Code / SAC Code etc. Invoice should be submitted in original for buyer plus duplicate for credit availment.
- 8. Payment of GST to Bidder will be made only if it is matching with data uploaded by the Bidder.



- 9. Bidders to give undertaking that GST as mentioned in the Invoice has been paid either through cash or admissible input credit and also filed the returns at the time of submission of invoice.
- 10. For invoices paid on Reverse charge basis "Tax payable on reverse charge basis" to be mentioned on the invoice.
- 11. In case GST credit is delayed/denied to BHEL due to non/delayed receipt of goods and/or tax invoice or expiry of timeline prescribed in GST law for availing such ITC, or any other reasons not attributable to BHEL, GST amount will be recoverable from vendor along with interest levied/leviable on BHEL.
- 12. In case vendor delays declaring such invoice in his return and GST credit availed by BHEL is denied or reversed subsequently as per GST law, GST amount paid by BHEL towards such ITC reversal as per GST law will be recoverable from vendor/contractor along with interest levied/leviable on BHEL.
- 13. Any offer not complying with the above clauses is liable to be rejected.

#### 2. PRE- QUALIFICATION CRITERIA:

- i. The Bidder should have a Registered and Incorporated office in India. Corporate Identification Number (CIN) shall be provided by the bidder.
- ii. **Local Presence**: Bidder should have office at Bengaluru area with supporting staff. Bangalore office address, phone no, contact person, mail ID to be furnished along with technical bid.
- iii. Bidder should have a clean track record, i.e. the bidder should not be under hold or blacklist by any of the BHEL units as on bid opening date. To this effect, a declaration should be given by the bidder along with technical bid.
- iv. The Bidder's Average Annual financial turnover during the last 3 years, ending 31<sup>st</sup> March of the previous financial year, should be at least INR 2 Lacks per year.
  - Certificate from bankers/chartered accountant/ $\Pi$  return/ Audited copy of annual report / balance sheet in this regard should be submitted along with the offer.
- v. Performance Certificate with respect to similar work executed in the other organization should be attached with the offer.
- vi. BHEL EDN shall pay for the ingredients as supplied along with Fixed / Service / labour charges ( if any ) and taxes after 30 days of presentation of bill. Non-acceptance of this term shall make your offer liable for rejection.

#### 2. General Instructions and Guidelines

#### TENDER EVALUATION

#### 4.1. Stage-I: Evaluation of Techno- Commercial Bid

- a) Techno-commercial bid of the bidder shall be evaluated for acceptability of Technocommercial offer. Format- A (Technical specification) to be filled and submitted along with technical offer.
- **b**) During the Techno-commercial Evaluation of the bid, clarification and gueries requested by BHEL shall be responded to within the reasonable time in order to avoid delay in evaluation of Techno-commercial bid. Failure to do so may result in rejection of the bid.
- c) Eligibility criteria are mandatory requirements to be met by the Bidder. Only those Bidders who meet all the requirements as per PRE-QUALIFICATION CRITERIA FOR BIDDERS will be considered for further evaluation.

#### 4.2. Stage -II: Evaluation of the Price Bid:

- a) Only Techno-commercial cleared offers will be considered for price evaluation.
- In case partial offer for certain category/items only received, the offer is liable for rejection. The tender is un-divisible i.e., single contract will be issued to L1 bidder. Price evaluation will be made on the basis of Format-B.
- Evaluation of the offer will be based on L1 of total cost to BHEL for the entire scope of c) work per month for the estimated consumption as per Format – B.
- d) The Total Price shall be for the complete scope, inclusive of comprehensive on-site maintenance including repair/replacement of parts during the entire period, All applicable GST etc., should be clearly indicated in price bid format.
- e) Discrepancy in Words & Figures - quoted in price bid
- 4.2.e.1. If, in the price structure quoted for the required goods/ services/ works, there is discrepancy between the unit price and the total price (which is obtained by multiplying the unit price by the quantity), the unit price shall prevail and the total price corrected accordingly, unless in the opinion of the purchaser there is an obvious misplacement of the decimal point in the unit price, in which case the total price as quoted shall govern and the unit price corrected accordingly.

- 4.2.e.2. If there is an error in a total corresponding to the addition or subtraction of subtotals, the subtotals shall prevail and the total shall be corrected; and

Willful misrepresentation of these facts shall be considered a fraudulent practice without prejudice to other remedies that BHEL take.

#### **COMMERCIAL TERMS & CONDITIONS**

#### 1.1. ORDER ACKNOWLEDGMENT

Letter of acceptance of the Order / Contract is to be submitted within one week.

#### 1.2. PERIOD OF CONTRACT:

The period of contract is for One year.

#### 1.3. VALIDITY OF OFFER:

The offer should be valid for 3 months from the date of opening of techno-commercial bid.

#### 1.4. PAYMENT TERM

Contract period will commence from the date of commissioning of vending machine along with all ingredients ( as ordered ). The payment will be made on monthly basis in arrears after completion of each month and submission of invoice(s).

BHEL EDN shall pay for the ingredients as supplied along with Fixed / Service / labour charges (if any) and taxes after 30 days of presentation of bill.

Payment will be through Electronic Fund Transfer (EFT) only. Details regarding bank account shall be provided in BHEL's standard format. The EFT or Pay link Direct Credit Form is enclosed. Bidder needs to fill the details as per the EFT or Pay link Direct Credit Form and attach a copy of Cancelled Cheque with it.

#### 1.5. MAINTENANCE

- The maintenance of equipment shall be under taken for the contract period from the date of a) order.
- The Contractor's/Vendor's responsibility under this contract shall commence from the date b) mentioned in our order.
- c) The maintenance will be comprehensive with Ingredients, spares and labor. The maintenance will be inclusive of replacement of all defective components of vending machine or to replace defective vending machine during the contract period. The defective component may be permitted out of BHEL premises with BHEL's permission.

- d) Vendor operator to ensure cleanliness of machine, water can, table / stand and etc.
- e) At least one operator for Two Vending machine as approved by BHEL shall be stationed in BHEL EDN by vendor for providing the desired levels of service. The operator shall be covered under all statutory coverage like Provident Fund, ESI, Insurance etc. by the bidder
- f) Providing the said services during BHEL office hours viz.,
  - Monday to Friday: 8:00 am to 4:30 pm
  - Saturday: 8:00 am to 12:30 pm

#### 1.6. DEDUCTION FOR DOWNTIME

#### a) DOWNTIME CALCULATION:

Breakdown of machine / non availability of ingredients for more than 48 hours , will be treated as service not available and prorate amount will be deducted from the Fixed / Service / labour charges ( If quoted/indicated in the offer ). If Fixed / Service / labour charges not quoted / indicated in the offer then Rs 200/ per machine per day will be deducted from your bill .

Downtime date and time will be entered in the register kept at BHEL. Vendor operator who will be present at BHEL has to take care of the corrective action. Wherever possible BHEL will communicate through mail / phone.

Any complaint/incident has to be resolved within 48 hours from the time of registration of complaint/incident. Deduction will be made from payment to the vendor for delay beyond the grace period.

**Number of days for downtime (N)**: Any downtime beyond 48 hours will be converted to number of days by dividing downtime hours by 24. Fractional day (more than are equal to 0.5) will be counted as full day for downtime calculation. Sundays and Holidays, if any will be included in the calculation of number of days for downtime.

Rate of Deduction: Rate of Deduction for a day will be calculated by dividing Fixed / Service / labour charges per month by 30.

#### 1.7. CONFIDENTIALITY
