**I. SCOPE OF WORK.**

The works Contract pertains to mainly Cooking services in the 'A', "B" & "C" shifts (6.00 hrs. to 14.00 hrs, 14.00 hrs to 22.00 hrs and 22.00 hrs to 6.00 hrs.) of BHEL in our canteens of BHEL Tiruchy for a period of two years.

(\*) However, the quantum of food items as well as the time of preparation are subject to the need and requirement from time to time.

**NOTE:** The ultimate responsibility for the quality and taste of food items lies with the contractor. The contract workmen should follow the instructions of the Canteen Officials (Head of Canteen, Supervisor In charge of Shift) in toto. The ingredients and recipe guidelines will be as per BHEL's norms. Any suggestion or change shall be only with the approval of BHEL's Canteen officials. Maintaining of smooth relations with everyone in the working group is absolutely essential. The workmen should be capable, flexible in mentality and accommodative in carrying out the job

## **II ELIGIBILITY CRITERIA:**

Following are the main eligibility criteria for this contract:

**EMD (Tender without EMD will be summarily rejected)**

**Service Tax registration and PAN card document**

- a) Contractor should possess previous orders of similar scope accumulated to the total value of Rs.20 lakhs during the last five years ending 31<sup>st</sup> December 2014.
- b) Contractor should also submit the satisfactory completion certificate as a proof from the firms where the services rendered.

**Documents to prove financial soundness of the firm / proprietor / company (in any of the following manner given below) for any of the two consecutive financial years out of four from 2010-11, 2011-12, 2012-13 & 2013-14 (Assessment year 2011-12, 2012-13, 2013-14 or 2014-15)**

- a) Copy of IT acknowledgement (or)
- b) Actual Profit & Loss A/c, Balance sheet is certified by a CA indicating his membership number.

***If the contractor does not fulfill even any one of the above qualifying criteria his/their offer will not be considered for price bid opening.***

## **III TERMS AND CONDITIONS :**

- ( a ) The rate quoted should be inclusive of all taxes for the work indicated under scope of work mentioned above.
- ( b ) The outsourcing rate for Cooking services are to be calculated as works Contract and deployed for the scope of above said work.
- ( c ) The bill for every month shall be prepared by the Contractor on the basis of the Work contract related to manpower and submitted to the Canteen Head for verification and a register should be maintained by the contractor for this purpose.
- ( d ) The consolidated statement and Bill shall be preferred by the Contractor on the last date of the month and submitted by 1<sup>st</sup> of every succeeding month to the Canteen Head for Certification and arrangements will be done by the Canteen Accounts for the payment by Finance department to the Contractor after 45 days from the date of receipt of the bill.
- ( e ) The Works Contract rate per Canteen will be constant during the contract period
- ( f ) To justify that the Contractor has adequate experience in taking up the contract of BHEL Canteens, the Contractor has to provide the list of customers / Industries / Institutions to whom the Contractor has rendered similar services so far. ( Please attach the copy of Work Orders received from the Industries / Institutions etc. for similar work)
- ( g ) If necessary, the Contractor may visit BHEL Canteens with prior notice and seek clarification, if any, before offering the most Competitive rate for taking up the works contract of Cooking services.
- ( h ) In case the lowest offer of rate for this Works contract does not meet BHEL scope of work given in the tender, BHEL reserves the right not to consider the same.

- (i) BHEL reserves the right to negotiate or re-float the tender opened if the L1 rate of the works contract is not the lowest acceptable value to BHEL inter-alia other reasons.

- (j) BHEL reserves the right to split the work order so as to have minimum two contractors to ensure uninterrupted supply by offering the contract in 60:40 ratio (**approx.**)

BHEL also reserves the right to negotiate the L1 rate and counter offer the L1 negotiated rate to L2 contractor. If the L2 contractor does not accept the counter offered rate, then the L3, L4 and so on contractors (except H1 vendor) will be counter offered the L1 negotiated rate

If no contractor accepts the counter offered L1 negotiated rate, entire quantity of 100% will be ordered on L1 contractor.

- (k) If there is any deficiency/ deviation in agreed services and alternate arrangement is not made immediately, BHEL will make arrangements to meet the exigencies of requirement and deduct the cost and damages involved from the contractor's bills.
- (l) The Contractor should have a minimum of one person, who is possessing a formal catering diploma/degree qualification, from a reputed Institution. The photocopy of the certificate in proof of qualification should be attached with the Technical bid.
- (m) The present menu for each day is attached (**Annexure-C**). Change in the menu will be informed whenever required and the contractor shall accommodate accordingly.

#### **IV. CONTRACT PERIOD**

The Contract period will be initially for 3 months on trial basis and subject to continuous satisfactory performance will be extended for a further period of 21 months. Further extension of 21 months Contract period shall be mutually agreed. However, the contract may be terminated due to violations or non-performance of the Contract conditions by giving **15 days notice**.

#### **V. EMD**

The EMD for the said work is **Rs. 2,00,000/-** (Rupees One Lakh only) and it should be furnished in the form of **DD in favour of Sr Manager/CWM BHEL/Trichy-620 014**. One time EMD is also acceptable subject to certification of validity by the competent authority. **Offers without EMD will be rejected.**

EMD of the Tenderer will be forfeited as per Tender Documents if:

- i) After opening the tender, the tenderer revokes his tender within the validity period or increases his earlier quoted rates.
- ii) The tenderer does not commence the work within the period as per LOI /Contract.

EMD given by all unsuccessful tenderers shall be refunded normally within fifteen days of acceptance of award of work by the successful tenderer. EMD shall not carry any interest.

## **VI. SECURITY DEPOSIT**

Security Deposit shall be collected from the successful tenderer. The rate of Security Deposit will be as below:

- Up to Rs. 10 lakhs: 10%
- Above Rs. 10 lakhs up to Rs.50 lakhs: Rs.1 lakh + 7.5% of the amount exceeding Rs. 10 lakhs.
- Above Rs. 50 lakhs: Rs 4 lakhs + 5% of the amount exceeding Rs. 50 lakhs.

The security Deposit shall be collected before start of the work by BHEL. The security deposit can be paid only in the form of DD drawn in favour of BHEL Tiruchi or in the form of bank guarantee of a Scheduled Bank.

The security deposit will be refunded,

- (a) On successful and satisfactory completion of the contract by production of no due certificate from the competent authority and deduction of recoveries of any.
- (b) If the contract is terminated by BHEL due to deficiency of service, after deducting the penal charges as decided by BHEL from the Security Deposit, the balance amount will be paid.
- (c) Security Deposit is not refundable if the contract is terminated by the contractor by giving notice before the stipulated period .

## **VII. INSURANCE**

BHEL will not be liable for any Medical attendance, injury / loss of life of the persons engaged by the contractor in the preparation or during the course of employment. A suitable insurance coverage for them may be arranged by the Contractor at contractor's cost.

## **VIII. EMPLOYEES.**

- (a) The contractor shall engage sufficient number of competent employees (say **at least 37 persons** for each day-One person should be team-leader of each canteen, who is accountable and can take decisions on behalf of the contractor) which is indicative of the quantum of job for the said cooking services. . The workmen deployed for this work should have completed **21** years of age and should not have crossed **55** years **as on 01.01.2015** and wear while on duty an acceptable uniform & sandak provided by the Contractor to carry out the works contract of cooking services at BHEL Canteens, and supervision thereof. Expenses on account of payment of salary / wages / provisions of food stuffs / food for the Contractor employees / Uniform minimum two sets, Apron, Kitchen Towel, Chef cap. / Personal Protective Equipment, and other benefits including statutory payments like PF, ESI,

Holiday wages, Gratuity, Bonus, etc., to the employees engaged by the Contractor shall be borne by the Contractor. The contractor shall have full control over his employees including the right to appoint, determine service conditions, discipline, discharge, dismissal etc. The contractor shall be solely responsible for any claim arising out of employment or termination of employment of his employees and for statutory payments. The contractor should observe BHEL security and safety regulation. Contractor should ensure that workmen follow safety rules & regulations as per BHEL's Safety rules & regulations.

The outsourcing rate for Canteen Cooking services are to be calculated as Works Contract and manpower deployed accordingly for the scope of above said work. **The contractor shall pay a minimum additional amount of Rs.3700/- per month to each workman employed by him for this work, over and above the Tamil Nadu Govt. minimum wages payable as per Minimum Wages Act as amended from time to time. The additional payment of Rs.3700/- will also attract all statutory payments such as PF, ESI, etc.**

Salary for the employees should be paid on or before 7th of every month preferably deposited in the workmen's savings bank account and submit the details to the respective Canteen Heads



Expenses on account of payment of salary / wages / provision of food for the Contractor's employees / Uniform / Personal Protective Equipments, and other benefits including statutory payments like PF, ESI, Holiday wages, Gratuity, Bonus, etc., to the employees engaged by the Contractor shall be borne by the Contractor. An amount of Rs.5/- per person per day is recovered as charges towards the food availed by the contract workmen. The contractor shall have full control over his employees including the right to appoint, determine service conditions, discipline, discharge, dismissal etc.

- ( b ) The contractor shall employ only male workers and such personnel who are medically fit. The company has right to direct the Contractor to remove from the premises such of his personnel who may be physically, hygienically, clinically or medically unfit and persons who lack the skill for cooking work (if so identified by BHEL) and the contractor should immediately arrange for replacement.
- ( c ) The contractor shall comply with the provisions of the Factories Act 1948, contract labour (regulation and abolition) Act 1970, ESI Act 1948, Workmen Compensation Act 1923, Employees Provident Fund and Miscellaneous Act 1952, Minimum Wages Act 1948, Payment of Wages Act 1936, Payment of Bonus Act 1965, Payment of Gratuity Act 1972, Services Tax if applicable, Tamil Nadu Catering Establishment Act, Tamil Nadu Industrial Establishment, (National & Festival Holidays) Act 1958 and the Rules framed thereunder or any other Laws and Rules as may be applicable from time to time to the workers engaged by him. The caterer when required by the Company shall produce the registers and records for verification and comply with other directives issued by the company for compliance of the statutory provisions.

The technical bids of the Contractors will be evaluated first and only such of those Contractors who are found suitable will be considered for their rate bid opening. Accordingly only the successful Contractors will be called to attend the **Price Bid opening and the date and time for the same will be communicated later.**
