#### **17.SETTLEMENT OF DISPUTES:**

If any dispute, controversy or claim arising out of, relating to, or in connection with, this contract, or te breach, termination or validity thereof, arises, both parties hereto shall endeavor to settle such dis ute amicably. Should this attempt fail, the disputes between the parties shall be resolved through art ration in accordance with the Arbitration and Conciliation Act, 1996. The attempt to bring about an articable settlement is considered to have failed as soon as one of the parties hereto, after reasonable attempts (which attempt shall continue for not less than 30 days); give 30 days' notice, in writing, invoing arbitration and calling upon the other party to constitute the tribunal as provided.

All or any such disputes or differences arising between the parties to this contract shall be referred to an Arbitral Tribunal consisting of single arbitrators. Sole arbitrator shall be appointed on mutually agreed by both the parties.

The place of arbitration shall be New Delhi for foreign vendors. The language of arbitration shall be E glish. The substantive law applicable to the substance of the dispute shall be the Indian Law. GISTC c use may be referred for this clause.

#### 19. Arbitration Clause:

In case of any dispute arising out of or in connection with this contract, the same shall be referred to rbitration under Arbitration & Conciliation Act 1996 of a sole arbitrator who shall be appointed by mut al consent of the parties. The seat & venue of arbitration shall be Haridwar. The proceedings shall be onducted in English. The governing law of the contract shall be the substantive Law of India.

## 20. Breach of contract, Remedies and Termination

In case of breach of contract, recovery of 10% of total contract value shall be applicable. Recovery shall be done by encashing security instruments like Contract Execution Bank Guarant e, performance bank guarantee. In case value of security instruments available is less than 1% of the contract value, the balance amount be recovered from other financial remedies (i.e. vailable bills of the contractor, retention amount, etc. with BHEL) or legal remedies shall be pt sued. Further, levy of liquidated damages, debarment, termination, de-scoping, short-closure, tc., shall be applied as per provisions of the contract.

## 21.Force Majeure Clause

- a) Either party shall be entitled to suspend performance of his obligations under the contract t the extent that such performance is impeded or made unreasonably onerous by any of the fc owing circumstances: fire, war, flood, riots, earthquake etc.
- b. The party claiming to be affected by force majeure shall notify the other party in writing im ediately without delay on the intervention and on the cessation of such circumstances. If force majeure prevents the purchaser from fulfilling his obligations, he shall not be forced to compessate the contractor for expenses.
- c. Regardless of what might otherwise follow from these general conditions, either party shall e entitled to terminate the contract by notice in writing to the other party if performance of th contract remains suspended under Clause Force Majeure for more than 6 months.

## 22.War Like Situation
