Further, if the tenderer fails to submit the figure (s) for 3 years, non-submitted year will be considered as "0" (Zero) for averaging the turnover. Tenderer should submit audited chartered accountant certified balance sheet, profit & loss statement, income tax returns for last 3 years.~~

**d. Proof of having experience in carrying out Similar Work to be submitted**

**Similar work** means Photography and Videography Services to any PSU or Government Office or Industry or any reputed private establishment.
