Bidders to note the following:

1. Please note the following w.r.t. change over logic in Technical specification:
"Interlock to be provided in such a way that in the event of failure of AC supply at AC MLDB/ACDB, the AC under voltage relay located in DCLDB shall sense the same & automatically close the DCLDB incomer (Contactor controlled)."
2. The due date of bid submission for subject tender is extended from existing date 02.09.2021, 02:00 PM to 09.09.2021, 02:00 PM. Part-I bids shall be opened on 09.09.2021, 04:30 PM (IST).
3. Delivery terms mentioned at point no. 7 of NIT, may please be read as following:

DELIVERY TERMS:

For Main Supply: Within Five (05) months from date of CAT-1 approval of Primary drawing/documents OR BHEL manufacturing clearance whichever is later, subjected to drawing/document submission/re-submission schedule as stipulated, in case of any delay in submission/re-submission of Primary drawing/documents, then same shall be reduced from the given delivery period. Delay in BHEL's comments/approval beyond 18 days shall also be considered for delay analysis.

For Mandatory Spares: To be supplied within Four (04) months from BHEL manufacturing clearance. Separate manufacturing clearance shall be given.

- In case BHEL manufacturing clearance date is later than the date of Cat-1 approval of Primary drawing/documents, then the contractual delivery period will be calculated by setting off the time gap between Cat-1 approval date of Primary drawing/documents and the manufacturing clearance date, from any delay by vendor in submission/re-submission of Primary drawing/documents.

All the other terms and conditions of the tender enquiry shall remain unchanged.
