#### **SPECIAL TERMS AND CONDITIONS**

- 1. The letters / packets are to be collected from BHEL CFP Rudrapur Office on every working day between 1.00 PM to 4.00 PM and shall be delivered within 24 hours in local Udham Singh Nagar Distt., within 48 hours in Delhi and its surrounding cities, in all metropolitan cities and 72 hours to all other places in India. In case of existing/ new BHEL sites/ offices the letters / packets will be delivered within 120 working hours (exclusive of Sundays and holidays). The signature acknowledgement (POD) with seal of the company for delivery at the correct address shall be submitted to concerned office of BHEL CFP Rudrapur as early as possible but positively within 10 days of dispatch of the consignment. Non- delivery should be immediately reported. The courier service personnel will ensure regular updating of the data pertaining to letters delivered, and hand it over to concerned official of BHEL.
- 2. In case the consignment is delivered to the destination after the fixed duration mentioned in point no. 1 above, but within 7 days after dispatch only Rs.5/- will be paid to the courier agency and beyond 7 days a penalty of Rs.50/- will be charged from the courier service. In case of non-delivery penalty may be levied at the sole discretion of BHEL which shall be maximum of Rs. 500.00 per case. The application of this clause shall not be applicable in cases pertaining to Force Majeure situation.
- 3. It shall be absolute responsibility of the courier agency to ensure that the contents of packet duly sealed / closed are not tempered with in any manner and are not stolen / misplaced/ lost/ mis-delivered. Suitable action including recovery of loss will be imposed for such defaults. The recovery of loss shall however, be limited to Rs. 500.00 per case.
- 4. The bills must be submitted on monthly basis duly supported by proof of delivery and then certified by BHEL authorized official.
- 5. Necessary transit insurance as needed should be arranged by courier service to cover the loss of any consignment in transit.
