## Part-I/ Cover-I: Earnest Money Deposit (EMD):

Only EMD of Rs.60,000.00 (rupees Sixty Thousand only) in form of Demand Draft/Banker's Cheque/ Pay order in favour of BHEL payable at New Delhi to be placed in cover-I.

### Part-I/ Cover-II: Techno Commercial Bid:

Please submit all information on Qualifying Requirements, copies of documentary evidence as asked for, original copy of tender document duly signed and stamped on each page as token of your acceptance to the tender conditions, and the check list duly completed. The cover to be properly sealed.

## Part-II/ Cover-III: Price-Bid:

Only price bid in the prescribed Price-Formats should be enclosed in Cover-III, duly sealed.

These three separate covers (Cover I, II & III) shall together be enclosed in a **fourth envelope** and this sealed cover shall be superscribed **with Tender name**, **Tender No.**, **Due date & Time** and submitted to this office.

The quotation should reach this office latest by 1500 hrs on 20.10.2009. Part-I, comprising EMD and Techno Commercial Bid will be opened at 1500 hrs on 21.10.2009 in presence of the representatives of the tenderers who choose to be present. Quotations received late or not received in line with the above procedure or not in the prescribed formats are liable to be rejected. The Cover-I containing EMD will be opened first. Cover-I10I / Techno Commercial Bid of only those bidders whose EMD is found in order will be opened later on the same day. Part-II / Price-Bid of only those parties who qualify in the techno-commercial bid will be opened later, for which separate intimation will be sent in due course of time.
