Sealed bids are invited by the Estate Officer for providing permission for temporary Licensing of vacant space for putting up a kiosk for sale of crackers for deepavali festival in Trichy BHEL Township, Kailasapuram, premises (Opposite to Nehru Stadium) as detailed below subject to the terms and conditions detailed in this Tender Notice. The tenderers shall submit their offer along with this document signed on all pages as acceptance of each of the terms and conditions listed.

DETAILS ARE AS FOLLOWS:

TERMS & CONDITIONS

01. **Space for Kiosk:** The total number of open vacant spaces that would be allotted for kiosk on open tender basis are four in numbers.
02. **Period of allotment:** The spaces will be allotted on temporary basis for construction of temporary Kiosks for a period of one week. i. e. from **24.10.2016** to **30.10.2016**.
03. **Earnest money Deposit/Security Deposit:** Demand Draft for Rs.1, 000/-should be drawn in favour of "**Bharat Heavy Electricals Ltd, Trichy-14**." towards EMD which will be adjusted towards the refundable Security Deposit or it may be forfeited in case the successful tenderer refuses to accept the award of temporary allotment or fails to complete the required formalities and occupy the open space within the specified and permitted time
04. **Minimum reserve price:** The minimum reserve price for the period of one week business i. e. from 24.10.2016 to 30.10.2016 is **Rs.10,000/-** plus Service tax + Swatch Bharat and Krish Kalyan Cess
05. **Mode of Allotment:** The first open vacant space will be allotted to the bidder, quoted highest amount (H1).The remaining three shops will be allotted to the consecutive three highest bidders (H2, H3, and H4) who have quoted lesser amount compared to H1 amount in descending order provided they accept to pay the H1 price for the space. If any of them do not accept it will be offered to the next bidder, in the order of the price quoted.
06. **Area of Vacant Space:** The area of one open vacant space that would be allotted for construction of one temporary kiosk is **37.2 Sq.Mtrs** (20 Sq. Ft. X 20 Sq. Ft).
07. **Payment:** The successful bidders will be asked to pay the license fee including Service Tax +Swatch Bharat and Krish Kalyan Cess at the time of allotment.
08. **Type of Kiosk:** Temporary kiosk (non-flammable) at the earmarked place only should be put up at the own cost of the permitted agency for the proposed temporary Cracker Sales (**Strictly in accordance with the norm fixed by the State Licensing Authority for this purpose**)

09. **License for business**: The successful bidders should have obtained the License Issued by the Statutory Authorities for this trade under the “Dangerous and Offensive Trade Act” before the Commencement of the business of crackers sales. **In any case they will not be permitted to start the business without the license.**
10. **Mode of applying**: Interested persons should apply by downloading the tender Application form (Price bid), filling it up with necessary details and dropping in at the Tender box, placed in 24 building BHEL, Trichy-620 014 along with a Demand draft for Rs.100/- drawn in favor of “***Bharat Heavy Electricals Ltd, Trichy-14***”.
