
This will be inclusive of all Personnel Protective Equipment, and other supplies to be provided by the contractor to their personnel as per scope of work.

B. IMPORTANT TERMS FOR PRICE BID & RATE BASIS:

Contractor has to quote only positive % up to two decimals points and it should be at least 0.01 or more (e.g. 3.43% {in figures} three point four three percent only {in words}) towards all related expenditure including all PPE, uniform, shoes, margin etc. Request for any other payment will not be entertained by BHEL for whatsoever reason except as indicated in Sr. No. 2. Changing any other value in Price bid will lead to rejection of the Price bid. Amount mentioned above are statutory in nature.

- 1. The service charges quoted shall remain firm and throughout the valid for entire Contract period and no extra payment will be reimbursed to the contractor by BHEL. Any revision in Daily Wages Rate made by BHEL based on Govt. Notification will be reimbursed/ adjusted based on actual payment made to contract labour. Service charges as indicated will not be applicable on such additional amount.
- 2. The Tenderer has to quote of **service charge only in %.** Price bid quoting in any other form will not be accepted and will be rejected. Price bid evaluation will be made on the basis of rate % quoted by bidder.
- 3. The service charge percentage should be quoted exclusive of GST and inclusive of any taxes and duties levied or to be levied both by Central and State Government authorities from time to time. GST will be paid extra on production of documentary evidence.
- 4. No other pre conditions along with your offer will be entertained by BHEL
- 5. Contractor should ensure that at least the prevailing minimum wages, as per the rules of Government of Tamil Nadu, which are applicable to General Engineering and Fabrication Industry and BHEL's additional wages, inclusive of bonus after remitting PF & ESI contributions, are paid to his employees ONLY in their respective bank accounts by means of NEFT/ RTGS/ IMPS.
- 6. While submitting the bills, the contractor should submit a proof of payment made to employees through bank, along with PF and ESI contribution challans to Welfare Section every month for effecting payment by BHEL. Otherwise payment to the bills will not be processed.
- 7. In addition, the contractor has to submit wage register as a proof for payment of Minimum wages and additional wages as per prevailing acts, for getting payment from BHEL
- 8. To illustrate, at present the minimum wages as per the guidelines of government of Tamil Nadu plus BHEL's additional wages inclusive of bonus being paid is tabulated above.
- 9. The above minimum wages as per the guidelines of government of Tamil Nadu plus BHEL's additional wages inclusive of bonus being paid is subject to change as and when the minimum wages are revised by the competent authority.

The signature at the bottom of the rate schedule confirms that the Tenderer had read and accepted all the Terms and conditions in Tender Schedule, also service charge percentage quoted by vendor is inclusive of all taxes and duties levied excluding GST.

CLARIFICATION REGARDING GST: In case any changes in taxes and duties as per Govt. Notification (including GST), the same shall be applicable from time to time.
