4. The Bid should be free from correction, overwriting, using corrective fluid etc. Any interlineation, cutting, erasure or overwriting shall be valid only if they are attested under full signature(s) of person(s) signing the bid else bid shall be liable for rejection.

5. Format for Part-1 Techno-Commercial Bid provided with the tender in Annex. – C is to be filled-up mandatorily and required enclosures attached.
6. The Bid must reach us sufficiently before **1100 hrs on 21.12.2020** and the Part-1 Techno-Commercial Bid will be opened on **21.12.2020** at **1400 hrs.** in the presence of those representatives of the bidders having authority letters from their companies.
7. **The Bid envelope should be inside the tender box (Green colour)** available in Tender room at Ground Floor, Administrative Building **before 1100 hrs. on 21.12.2020**. Bid received after 1100 hours shall be considered as late tender and is liable to be rejected.
8. Earnest Money (EMD) of Rs. **1,40,462/-** as mentioned in Annex. – A: **The EMD is to be paid either (i) by online mode as per clause 22 of NIT above (e-Payment) and/or (ii) in the form of FDR issued by Scheduled Banks/Public Financial Institutions as defined in the Companies Act (FDR should be in the name of the Contractor, a/c BHEL). No other mode of payment is acceptable. The EMD paid shall not carry any interest. 10. **The enclosed scope of work, as detailed in the tender, covers only the major work / activities. In addition, if any other related activities for the completion of job are needed, as per general maintenance requirement and site conditions, they have to be carried out without any extra cost.**
11. Penalty for delay shall be as per Penalty Clause (Cl. 1.5 in Annex. – A & Cl. J.2 in Annex. – B).
12. BHEL is not responsible for the tenders/ bids lost / delayed in transit / by post etc. Any Bid reaching this office after due date & time or without EMD & Tender Fee will not be considered.
13. The selected Contractor will have to mobilize their team (Reporting at site) with all pre-requisites within 7 days of intimation.
14. The validity of Bids should be six months from the date of tender opening.
15. The decision of the Tender Committee shall be final and binding on the bidders.
16. **Bid not received in line with the tender enquiry is liable to be rejected.**
17. It is requested that only authorized representative of the bidder attends the tender opening.
18. All tools & instruments and their mobilization is Contractor's responsibility. Contractor shall ensure use of only calibrated Inspection / Measuring / Testing Equipment conforming to national standards. Valid calibration certificate shall accompany these IMTEs.
19. "Code for Safety Management at Services Sites" in Annex. – E, "Statutory Liabilities of the Contractor" in Annex. – F, "Compensation in cases of death/permanent total disablement" in Annex. – H, "GST Clause" in Annex. – I and "Arbitration & Law" clause in Annex. – J, are to be accepted by the party for qualifying in Techno-Commercial bid.
20. **Part-2 Price bids of only those parties will be opened who qualify in the Techno-Commercial bid.**
21. After receipt of work order from BHEL (if found technically suitable with L-1 price), Contractor has to sign a Contract Agreement on Rs. 500 Stamp Paper covering all terms and conditions of work order. Stamp duty charges shall be borne by the Contractor.



SD deducted from Running Account bills shall be returned 90 days after expiry of contract.

EXECUTING AGENCY	BHEL, BHOPAL: CEE – CXX DEPT.

A. SCOPE OF WORK

Commissioning, Servicing, Maintenance, Spares Replacement, Trouble-shooting etc. of the BHEL supplied Digital Excitation Equipment (DEE) / Electro-Hydraulic Governor (EHG) / Large Current Rectifier / Sync Panels / EC PANELS / WAG-7 / CMS products etc., as per Customer / BHEL requirement within the stipulated time period, against each work.

Required instruments, tools etc. are to be carried by the CONTRACTOR representative for execution of the work at site. BHEL shall provide only Spares / Replacement items if required.

1. SITE SERVICES: Site services are stipulated in the following main areas:

1.1 Digital Excitation Eqpt. (DEE) / Static Excitation equipment (SEE)/ Electro Hydraulic Governor (EHG)/ Sync Panels/ EC Panels:

BHEL supplied **Digital Excitation Eqpt. /SEE for synchronous generators and motors, Electro Hydraulic Governors for synchronous generators, Sync Panels and EC Panels** to Captive / Thermal / Hydro / DG Power Plant customers of various industries, thermal, nuclear & hydro sites all over India, as per Job Work Orders / Instructions provided by BHEL.

1.2 Large Current Rectifier: BHEL supplied equipment across all over the India.

Major works shall involve:

Commissioning which shall include

- Checking the physical condition of the of the new DEE / Rectifier product, Pre-commissioning checks of the Modules, Interlocking, Indications & Protections, Conduct No-Load & Dummy Load as well as Load Tests as detailed in commissioning instructions.
- If on energization the desired results are not achieved, Trouble shooting of DEE / Aux. Conv. Shall be required during No-Load / Load Test for resolving the problem.
- Commissioning activities at a site for DEE may be split up in the following two phases, if the customer is not able to provide full load testing / synchronization in one go:
 - Phase-I, Dummy load & Part loading of the DEE.
 - Phase-II, Full load and Grid Synchronization, PF Control etc., as required.
- Trial Runs & Demonstration to customer and tuning/calibration.
- Software uploading (Software shall be provided by BHEL)
- Obtaining joint note / MOM / Completion Certificate from the customer.

Customer Complaint Resolution / Trouble-shooting after commissioning involving:

- Identifying the problem.
- Repairing / rectification / replacement of the above equipment / system, making use of spare components supplied by BHEL / Customer
- Conduction of Load test / Synch. With grid for DEE, if reqd. / Trials Runs for Aux. Conv., demonstration to customer, making joint note / MOM.
- Implementation of modifications, if any.

1.3 **Composite Monitoring System:**

Major works shall involve:

Commissioning work of composite monitoring system of per phase GT or per 3 phase ICT transformer consisting of

1. **Interface connection checking:** Signals from cooler control cabinet, marshalling box, tap changer box, etc will come through cables at terminal box of outdoor panel. Contractor to check and verify the connection as per the list and scheme provided by BHEL.
 - a. Total digital inputs: Maximum 96
 - b. Total Digital output: Maximum 20
 - c. Total Analog inputs: 10
 - d. Total CT signals: 3
2. **Powering up the cubicles**
 - a. There are various power supplies (AC/DC, DC-DC) which are needed to energize the cubicles.
 - b. Two different supplies are required in each cubicle.
 - c. Operation of MCB change over circuit operation & field system energization to be ensured.
 - d. The supply connection is to be verified by contractor, whether the designated supply cables are being terminated at proper TB's.
 - e. Main MCB's to be turned ON and Voltage level to be checked with multimeters.
 - f. Racks to be turned on.
 - g. Detail powering up process shall be provided to successful bidder.
3. **Fiber optic connection work between outdoor & indoor unit.**
 - a. The fiber optic connection is to be established between indoor & outdoor unit of CMS system. The fiber optic cable will already be laid at site. Associated LIU and patchcords will be inside cubicles.
 - b. Contractor to arrange for splicing & connection of patchcords with fiber cable through LIU's
 - c. Total splicing is to be done for 4 pairs of fiber optics with LIU.
 - d. After connection, the patchcords are to be connected in respective racks.
 - e. Both the racks are to be turned on & LED status to be checked for active connection.
4. **Signal transmission check**
 - a. Digital inputs: One by one all the digital inputs to be verified by actually operating the concerned MCB or contactor or shorting the designated TB's in CCC/CMB / tap changer panel. The DI status should change in HMI of indoor panel.
 - b. Analog input: The actual reading of analog channels at source end to be measured and verify with that being displayed at HMI.
 - c. Digital output: The digital outputs are to be operated through test mode in HMI, and actual Fan & pump operation to be observed.
5. **Testing & verification of ladder logic**
6. **Connection to SCADA/data concentrator**
 - a. Connecting Ethernet cable / FOC cable to SCADA / Data Connector Panel from indoor panel
 - b. Configuring IP address provided by SCADA vendor in indoor panel
 - c. Providing icd file (as given by BHEL) to SCADA vendor and confirmation with
7. **Attending of shipping points related to complete CMS system**

1.4 **WAG-7 Loco:**

Activities to be carried out at BHEL Jhansi in WAG7 Loco

1. **Supervision of Erection, Commissioning & troubleshooting of HT-1(BA1) Panel, HT-2(BA2) Panel and HT-3(BA3) Panel.**
2. **Supervision of Erection, Commissioning & troubleshooting of LT-2 (AC2) Panel.**
3. **Supervision of Erection, Commissioning & troubleshooting of Converter Panel along with Heat Exchanger.**
4. **Line Trials for customer clearance. Capturing data and assisting in fine tuning of the system which may involve removal and re-installation of devices.**

The above activities will be required to be attended on call as and when required. Manpower to be provided on as required basis to finish the job in stipulated time on daily rate contract basis.

Troubleshooting, rectification, minor modification, if required, shall be in the Contractor's scope to full satisfaction of Customer. Signing of MOM is also included in the Contractor's scope.

For the above works of testing, trouble shooting and commissioning necessary instructions / procedures shall be provided by BHEL.

Note:

1. All tools, instrument as required during commissioning/troubleshooting (Multi-meter, Clamp-meter Crimping Tools, Hand tools, blower etc.) shall be in contractor's scope.
2. Minor works shall be in scope of contractor, though defining the compete minor work is not possible, however some of the minor modification such as changing NO to NC contacts, replacing terminal blocks, painting at damaged places of cubicle, tightening of wire termination, providing one to two extra wires, crimping of lug came out, putting of few identification labels, replacing panel locks, replacement of fused filament bulbs, rerouting of few cables, putting cable ties, putting/replacing wire ferrules, etc. Contractor to quote considering above minor modifications may arise. No separate charges shall be payable for minor modifications. Any Major modification to be informed to BHEL. BHEL shall decide suitable action.
3. Contractor may be required to depute manpower in two shifts (if demanded by Customer/ BHEL). Manpower to be provided on as required basis to finish the job in stipulated time. Commissioning Report formats shall be provided by BHEL to the Contractor. The Contractor shall duly fill up the same and submit to BHEL with completion report. Signing of the Commissioning Report by Customer/or BHEL representative shall be in the contractor's scope.

B. TERMS & CONDITIONS:

1. Contractor shall make deputation as per call given by BHEL, maximum within 7 Days of period.		
2. The daily rate charges shall be paid for the period(s) of actual working at site, based on the Time Sheets / Certification by BHEL / Customer / Site Representative.		
3. <u>Journey DA:</u> Fixed DA charges @ <u>Rs 324/- per day</u> towards travel / journey time shall be paid. For part- hours journey period payment shall be made based on: (a) 3-6 Hrs = ¼ DA, (b) 6-12 Hrs = ½ DA (c) More than 12 Hrs shall be Full DA.		
4. In case BHEL Bhopal calls the party for (i) Material / Spares collection (ii) Providing Technical / Commercial inputs like Drgs. / Schemes, guidelines, Offers / Bill chase-up (iii) Associating in the testing of the Eqpt. other than during Training Period, following Charges shall be permitted:

5. The person(s) called for at BHEL or deputed to site will make his/their own arrangement for stay / lodging & boarding.		
6. After job completion, the contractor shall submit the Invoice for number of days worked at site, along with other vouchers.		

7. The Contractor will make his own arrangement for the necessary insurance of his (i) personnel (ii) instruments / tools / tackles, test eqpt against accidents, damage, theft or fire etc. Necessary workmen compensation insurance is contractor's responsibility.
8. The contractor shall carry out and complete the specified work(s) to the entire satisfaction of BHEL.
9. BHEL shall not reimburse any expenses towards (i) insurance cover for contractor's Persons deputed for site work, tools, instruments etc. (ii) any medical expenditure (iii) transport of his tools / instruments, personal luggage etc.
10. Rly Journey: To and Fro railway fare upto site, equivalent to II-AC incl. Tatkal Chgs., (if paid), for Graduate Engineer and III-AC incl. Tatkal Chgs., (if paid), for Diploma and ITI holders will be reimbursed. Journey particulars (Train Name, Train No. Tkt No., Stn From, Stn To, Distance, Date & Time of Departure, Date & Time of Arrival, Fare etc) to be furnished with the bills / invoices and the same shall be self-certified.
11. Road Journey: Where train journey is not available / longer distance / more time consuming, Road travel charges shall be reimbursed @ <u>Rs 5/- per Km</u>
12. Local Conveyance: (i) Where Customer or BHEL is not providing any conveyance to the site from the stay place, re-imbursement @ <u>Rs 203/- per day</u> shall be permitted. For GHA within the Factory premises provided by customer, this shall not be paid. (ii) Local conveyance to / from Place of Residence / Hotel / GH from / to Rly. Station / Bus Stand shall be Paid @ <u>Rs. 203/- per trip</u>
13. Journey by Air: In case of urgency of work, especially in the North-Eastern region of India, journey by air may be permitted for both the categories. Re-imbursement for Air travel shall be made only on production of Original Flight Tickets (Paper Tkt. / e-Tkt.) and Original Boarding passes along with GST Invoice copy for Air Ticket.
14. Depending on requirement, the contractor shall have to depute his person(s) even on 24 hours' notice (to leave HQ), as per BHEL requirement to attend site work.
15. Drawing, Schemes/ Wiring shall be provided by BHEL for successful bidders during deputation at site.
16. Contingency purchases/ Miscellaneous Expenses: Contingency/Miscellaneous re-imbursement against expense of Misc. Purchases / Telephone Chg./ Porter Chg./ Inside BHEL expenses / Air Travel during urgency / Purchase of Paint / Brush / Hardware / Minor Tools / Plates / Sheets / Helmet / Gloves / Apron and other items as per requirement at site limited to Rs. 204600/- subject to production of Bill and certification by BHEL.

C. CONTRACT VALIDITY & REVIEW OF PERFORMANCE:

1. Contract shall be valid **two years** from the date of signing of contract.
2. BHEL may short close the contract without assigning any reason.
3. BHEL shall appraise the performance of the contractor during testing, commissioning and functioning of the system and any other work done by contractor and shall be entitled to reject any work which, is not in full accordance with their expectations BHEL reserves the right to even terminate the contract unilaterally.

D. CONFIDENTIALITY:

The Contractor shall not mis-utilize, issue to others any confidential information like Schemes / Drgs, Manuals, Instructions etc pertaining to the BHEL equipment / system nor shall attend to any site complaints for the said Equipment directly on private basis during the tenure of contract. Contractor

shall also not manufacture and supply the products, as covered for erection and commissioning in this NIT, to BHEL customer in next 10 Years.

E. STATUTORY LIABILITY & ADHERANCE TO SAFETY MANAGEMENT CODE:

Where the Contractor Company has employed workers for these services, the enclosed Statutory Rules / Regulations viz. “Code for Safety Management at Services Site” and “Statutory Liabilities of the Contractor” (vide Annexures - E & F) are to be accepted and followed by the party and feedback against compliance to be provided to BHEL.

G. CONTRACT VALUE:

- Personal Protective Equipment: Provision & use of personal protective equipment conforming to Indian or equivalent standards to all employees of BHEL & its sub-contractors working at sites shall be ensured as specified below:
- Safety Helmets Conforming to IS:2925 shall be worn by all at sites where there is any possibility of any object falling from overhead.
- Safety Belts (Type 2) Conforming to IS: 3521 shall be used with the life line properly tied, by any person who is required to work at an elevated location from where there is possibility of fall of the person by more than two meters.
- Person who might be exposed to any hazards to his eyes & face during the course of his work shall use 2.1.3 Eye & Face Protection Device Conforming to IS: 8940 or 8520.
- Ear protection Device Conforming to IS: 6229 shall be used by any person exposed to excessive noise in his work.
- Hand & Body Protection Devices IS: 2573 or 6994 or 8519 or 8807 as applicable shall be used by a person who might be exposed to the possibility of Injury to his hand or body while executing a particular task.
- Foot Protection Devices: Safety shoes or good quality covered shoes, depending on the degree of hazard one is likely to be exposed to, shall be worn by persons engaged at servicing sites.

HOUSE KEEPING

- Materials, equipment etc. shall not be placed or left work area so as to obstruct safe movement of people or cause any other mishap.
- Work places & passageways that are slippery due to oil, water etc. shall be cleaned up or strewn with sand/similar substance.
- Action shall be taken to discourage the practice of throwing materials/ equipment from elevated locations to lower levels.

ILLUMINATION

- Rolling & dragging gas cylinder shall be allowed but suitably designed cage system shall be used for lifting of gas cylinders to elevated work locations and also for lowering them.

FIRST AID

- Contractor shall be required to maintain a first aid box with essential items. The box shall be available for use at all hours of work.

STATUTORY REQUIREMENTS

- Adherence to all local, state and central legislation on safety measures as applicable to the work at site shall be ensured.
- This document may be treated as a part of the NITs and your acceptance of these requirements will be essential for qualifying to work as our sub-contractor.

Sub: Compensation in cases of death/ permanent incapacitation of person due to unintended/unforeseen occurrences during the manufacturing/ operation and works incidental thereto at BHEL factories/ offices and precincts thereof , project execution, erection and commissioning, services, repairs and maintenance, trouble shooting, serving, overhaul, renovation and retrofitting, trial operation, performance guarantee testing undertaken by the company or during any works/during working at BHEL Units/ Offices/ townships and premises/ Project Sites.

- a) *Victim: Any person who suffers permanent disablement or dies in an accident as defined below.*
- b) *Accident : Any death or permanent disability resulting solely and directly from any unintended and unforeseen injurious occurrence caused during the manufacturing/ operation and works incidental thereto at BHEL factories! offices and precincts thereof, project execution, erection and commissioning , services, repairs and maintenance, trouble shooting, serving, overhaul, renovation and retrofitting, trial operation, performance guarantee testing undertaken by the company or during any works/during working at BHEL Units! Offices! townships and premises! Project Sites.*
- c) *Compensation in respect of each of the victims:*
 - (i) *In the event of death or **permanent disability** resulting from **Loss of both limbs**: Rs. 10,00,000/- (Rs. Ten Lakh)*
 - (ii) *In the event of **other permanent disability**: Rs. 7,00,000/- (Rs. Seven Lakh)*
- d) *Permanent Disablement: A disablement that is classified as a permanent total disablement under the proviso to Section 2 (l) of the Employee's Compensation Act, 1923."*

"BHEL shall recover the amount of compensation paid to victim(s) by BHEL towards loss of life / permanent disability due to an accident which is attributable to the negligence of contractor, agency or firm or any of its employees as detailed below.

GST CLAUSE

1.  - 2.2.6 Contractor has to give an undertaking to BHEL that they have declared invoice in his return and paying GST within timeline prescribed for availing ITC by BHEL. Payment to Contractor for GST portion will be released only after completion of above activity and on BHEL availing ITC Credit against the respective bill.
4. In case GST credit is delayed/denied to BHEL due to **non/delayed receipt of services/goods and /or tax invoice** or expiry of the timeline prescribed in GST Law for availing such ITC, or any other reasons not attributable to BHEL, GST amount shall be recoverable from the contractor along with interest levied/leviable on BHEL.

Reverse Charge under GST

- 5A. In respect of services, reverse charge liability shall arise at the earliest of date of payment to service provider or 60 days from the date of issue of invoice by service provider. Contractor has to submit bill for payment within 30days from the date of invoice. Any interest or penalty implications attributable to the contractor shall be recovered from them.
- 5B. Any GST liability arising on BHEL under reverse charge before actual receipt of goods and/or invoice thereof would be subject to recovery of interest leviable for the period between the date of such liability and actual date of eligibility of ITC based on receipt of goods, receipt of invoices and other condition specified in GST Law.

Penalty

6. Penalty if chargeable from suppliers/contractors as per NIT, applicable GST will be charged in addition to the same.

Tax Deduction at sources

7. TDS as per extent provisions of the GST Law shall be deducted from supplier/contractor bill.

ARBITRATION & LAW

1. All disputes between the parties to the Contract arising out of or in relation to the Contract, other than those for which the decision of the Engineer in the Contract or any other person is expressed to be final and conclusive, shall after written notice by either party to the contract to the other party, be referred to sole arbitration of the General Manager or his nominee. The Arbitration shall be conducted in accordance with the provisions of the Indian Arbitration and Reconciliation Act, 1996.
2. The parties to the Contract understand and agree that there will be no objection that the General Manager or the person nominated as arbitrator had earlier in his official capacity directly or indirectly dealt with the matters to which the Contract relates or that in the course of his official duties had expressed views on all or any of the matters in dispute or difference. The award of the arbitrator shall be final and binding on the parties to this contract.
3. The arbitration proceedings shall be held at Bhopal.
4. **MODEL CONCILIATION CLAUSE FOR CONDUCTING CONCILIATION PROCEEDINGS UNDER THE BHEL CONCILIATION SCHEME, 2018**

The Parties agree that if at any time (whether before, during or after the arbitral or judicial proceedings), any Disputes (which term shall mean and include any dispute, difference, question or disagreement arising in connection with construction, meaning, operation, effect, interpretation or breach of the agreement, contract or the Memorandum of Understanding (delete whichever is inapplicable), which the Parties are unable to settle mutually), arise inter-se the Parties, the same may, be referred by either party to Conciliation to be conducted through Independent Experts Committee to be appointed by competent authority of BHEL from the BHEL Panel of Conciliators. Notes: 1. No serving or a retired employee of BHEL/Administrative Ministry of BHEL shall be included in the BHEL Panel of Conciliators. 2. Any other person(s) can be appointed as Conciliator(s) who is/are mutually agreeable to both the parties from outside the BHEL Panel of Conciliators. The proceedings of Conciliation shall broadly be governed by Part-III of the Arbitration and Conciliation Act 1996 or any statutory modification thereof.



Subject: Relaxation of Norms for Startups and Micro & Small Enterprises in Public Procurement on Prior Experience – Prior Turnover criteria.

- (1) The Government of India has notified Public Procurement Policy for Micro and Small Enterprises (MSEs) Order 2012 with effect from 1st April, 2012 and 20% procurement from Micro & Small Enterprises of the total procurement by Central Ministries/Departments/CPSUs has become mandatory with effect from 1st April, 2015.
- (2) The Government of India has announced 'Startup India' initiative for creating a conducive environment for Startups in India.
- (3) The Startups are normally Micro and Small Enterprises which may not have a track record. These will have technical capability to deliver the goods and services as per prescribed technical & quality specifications, and may not be able to meet the qualification criterion relating to prior experience-prior turnover.
- (4) In exercise of Para 16 of Public Procurement Policy for Micro and Small Enterprises Order 2012, it is clarified that all Central Ministries/Departments/ Central Public Sector Undertakings may relax condition of prior turnover and prior experience with respect to Micro and Small Enterprises in all public procurements subject to meeting of quality and technical specifications.
- (5) This issues with the approval of Union Minister of Micro, Small and Medium Enterprises.
