Sealed Tenders are invited in 2 Bid System i.e. 'Technical cum Commercial Bid' and 'Price Bid' for the above work from competent contractors. Tenders shall be sold by **CPR Department** up to **11.00 Hrs** on **10.03.2016.** Filled tender documents shall be received in tender box kept in CISF room at ADM Building entrance gate up to **13.15 Hrs**. on 11.03.2016. 'Technical cum Commercial Bid' shall be opened on the same day at **14.00 Hrs**. Price Bid shall be opened at a later date after acceptance of 'Technical cum Commercial Bid'.

Tender document can be purchase from CPR Department by depositing Rs. 228/- (Rs. 200/- + VAT14.5%) in cash office or same can be enclosed in the form of DD. If tender is down loaded from our website www.bhel.com. The tender cost Rs. 228/-- must be enclosed along with "Techno-commercial Bid'.

PART-'B' TERMS & CONDITIONS OF CONTRACT

- 01. The bidding is in 2 stages i.e. (1) Technical cum commercial bid and (2) Price bid
- 02. The price bids of only those bidders will be opened who qualify the first stage.
- 03. Bidders will have to fulfill all the requirements raised by the appropriate authorities for which no financial burden shall be passed on to BHEL. The full burden will have to be borne by the bidder.
- 04. The bidders are required to quote the **rates** in Rupees only for Indica (without fuel & driver). There should be no cutting or over-writing in the price bid. Please ensure while filling the price bid.
- 05. For the purpose of deciding the lowest bidder the general formula shall be used to decide L1:
- 06. Payment will be made to Bidder on the basis of actual Kilometers completed to different places. Bidder should submit bill on monthly basis supported with log book and other related documents. The service provider will submit proof of Service Tax deposit challan along with the bill if applicable.
 - *Brand new means- 'a new vehicle purchased after publication of this tender notice in news paper/website'.
- 07 Monthly bills will have to be submitted in the standard format. The Pool Supervisor will make appropriate necessary corrections before forwarding the bills for payment. Bills not submitted in the standard format will not be accepted for which the contractor will be held responsible.
- 08. The bidder will have to raise monthly bills for the service rendered; these bills shall be scrutinized by BHEL before payment. Failure to submit the bills within 3 months of the service rendered may disqualify the bidder from any claims. BHEL shall not be responsible for making any payment for which bill has not been raised/submitted to BHEL Jhansi. The bills should be in the format in which price bid has been made. Service Tax, if any, shall be paid extra.
- 09. The billing period will begin from the 1st/15th day of a calendar month. Bidder should strive to place the vehicle/taxi on 1st/15th day of month.
- 10. The validity of the contract shall be Two years from date of LOI/Contract.

- 11. The ordering/contract will be finalized on lowest technically qualified bidders only.
- 12. Offers shall be accompanied with **Earnest Money Deposit** (EMD) of Rs.10,000/- Ten Thousand only) in the form of Demand Draft, in favour of BHEL Jhansi or BHEL cash deposit receipt. Bidders can also submit one time EMD by depositing Rs. 2,00,000.00 (Two Lacs) in cash office & certificate of one time EMD may be enclosed along with tender. Offers without EMD shall be liable to be rejected. The EMD shall be refunded to the unsuccessful bidder(s) after award of work by BHEL and acceptance by the successful bidder.
- 13. <u>Security Deposit (SD)</u>: Security deposit as per Works Policy 2008 Para-8.1.1 will be collected from the successful bidder <u>before start of the work</u> in the form of either Cash or Pay order or DD or NSS or KVP or Bank Guarantee. The directives given in BHEL Works Policy 2008 shall be fully followed. EMD of Rs.10,000/- will be treated as Security Deposit for the contractor to whom the contract is awarded. The S.D will be refunded to the contractor after satisfactory completion of the work and after making necessary recoveries, if any.
- 14. Successful bidder will pay the Stamp Duty on Security Deposit as per government Rules.

DEDUCTION

- 15. One extra set of cleaned & ironed white seat covers will have to be kept ready for providing during VIP visits. In case of failure to do so, BHEL will get the same prepared and deduct the amount from the bills apart from recovering a penalty of Rs.500/-.
- 16. In case of breakdown of the taxi on any day, another taxi will have to be provided. In case of failure to provide another car, a penalty @ Rs.500/- per day will be imposed. This will be allowed only for maximum 7 days, after which management reserves the right to terminate the contract at the risk & cost of the bidder.
- 17. The front & rear wind screens should have a sticker reading "ON BHEL DUTY". The taxi will be parked in BHEL for which suitable place will be provided. In case of failure to do so, BHEL shall, deduct the charges from the contractor's bills and recover a penalty of Rs.100/- per day.
- 18. Placard indicating name of Guest, name of Company etc. will have to be displayed by the driver at the Railway station for receiving incoming guests. The Transport Pool In-charge will give details from time to time. Failure to comply with this provision may result in a penalty of Rs.100/- per incident. Each vehicle has to keep two sketch pens, white sheets, blade & cello tape for writing the name of the arriving guest and paste it on the front wind screen. Failure to do so would invite penalty @ Rs.50/- per incident.

- 19. The Car will have to be maintained by the contractor in good running condition which includes at least the following:
 - i. Minimum noise of engine and body while running;
 - ii. Tyres with proper treads;
 - iii. Inflated Stepney;
 - iv. Working headlights, tail lamps, indicators, speedometer, milometer, temperature indicator etc:
 - v. Proper paint on the outside;
 - vi. Good condition of bumpers;
- vii. Upholstery in good condition including washed and ironed white seat covers;
- viii. Proper locking of all doors;
- ix. Proper closing and opening of all windows;
- x. Dusting of dashboard, rear board, matting, windscreen, windows and body.

Failure to maintain the same would invite penalty @ 1% of bill for each failure for the duration of the failure/lapse.

- 20. While on Station duty, taxi will have to be parked near Main Porch/Enquiry/Statues. Railway Station/other places parking charges in Jhansi to be borne by the contractor. No reimbursement shall be allowed for this. Failure would result in penalty of Rs.50/- per incident.
- 21. Contractor/Operator will have to fulfill all legal obligations regarding Pollution Norms, Motor Vehicle Act, Service tax etc. as may be applicable to him. The vehicle should have valid taxi permit issued by R.T.O., Jhansi. The vehicle must be comprehensively insured for driver, passengers & the third party for the period of the contract.
- 22. The vehicle may be deputed for election duties. During this period, payment shall be made as per contract after deducting the cost of fuel and other reimbursement received, if any, by the driver from the Election authorities.
- 23. The vehicle(s) may be required to go outside Jhansi. Permit charges of other States be reimbursable against documentary proof.
- 24. The contractor has to abide by all laws, rules & regulation applicable to this type of work. Ignorance of the same does not entitle him to any concessions or claims.
- 25. Any dispute(s) or difference(s) arising out of or in connection with the contract shall to the extent possible in the first instance be resolved amicably between the contractor and BHEL.

In case a dispute is not resolved, the same shall be referred for conciliation by an officer of BHEL. In case, it still remains unresolved, the dispute will be referred for arbitration by an officer of BHEL. (In case arbitration by an officer of BHEL's is not acceptable, the same could be entrusted to any mutually agreeable common functionary or an independent person). The arbitrator will give his award within the shortest period. The award of the arbitrator shall be final, conclusive and binding on both parties.

The arbitration proceeds shall be conducted in accordance with "Indian Arbitration and Conciliation Act 1996 or any statutory modification thereof. Language of the Arbitration proceedings shall be in English. The venue of Arbitration shall be Jhansi, India. The court of Jhansi shall have exclusive jurisdiction.

- 27. Any matter of dispute arising out of or in connection with this contract shall be under jurisdiction of Jhansi Court only.
- 28. The Contractor has to make an agreement with BHEL in the format prescribed only on Rs. 100/-Non-Judicial Stamp Paper.
- 29. In case of non satisfactory performance of the contract, BHEL shall have a right of forfeiting the security deposit.
- 30. The Contractor shall compensate BHEL for any loss or damage to the plant/property, material of BHEL due to his workmen/ representatives' negligence or otherwise during execution of contract.
- 31. BHEL reserves the right to accept or reject any or on offers without assigning any reason (s). The dispute arising out of or in relation of this agreement shall be referred to arbitrator who may be a serving/retired Sr. Officer or any other person of repute whose award shall be binding on both the parties to the agreement. In case any of the parties decides to obtain relief from the court, the dispute arising out this agreement shall be subject to Jhansi jurisdiction.

I HAVE READ AND UNDERSTOOD ALL THE TERMS & CONDITIONS.THE ABOVE HAVE BEEN UNDERSTOOD FROM BHEL OFFICERS / SUPERVISORS. ALL TERMS & CONDITIONS ARE ACCEPTED.

NOTE:

- The vehical shall be operated by Diesel only. The vehicle should be brand new models without factory fitted gas-system. If during the contract period, it is found that is same is run by other fuel/gas, suitable action shall be taken against the bidder/contractor or contract may be terminated.

QUALIFYING REQUIREMENTS

The bidder should submit the following documents along with the offer and comply with the requirements:

- 1. Should have PAN/TAN Number (copy to be enclosed)
- 2. Should have Service Tax Number (PAN Based) (copy to be enclosed)
- Self Certificate that he is not Blacklisted/Banned/Delisted on the date of tender.
- 4. Self Declaration that he is not Blacklisted/under hold from BHEL Jhansi or banned by any Unit/region/office of BHEL.
- 5. Declaration that he is not guilty by a Court of Law in India for any offence involving fraud, dishonesty and moral turpitude.

6. Financial Strength:

Mininum Annual Turnover from operation of Travel/Tours should be Rs.1.61 Lakhs per annum in any one year in last three years 2010-11, 2011-12 and 2012-13. As a proof copy of Income Tax Returns/TDS Certificate to be submitted.

7. Ownership of Fleet and Experience:

The bidders should have ownership of minimum 2 Taxi/Vehicles(four wheeler) and experience of running Travel/Tour business.
