3)	<u>Technical scrutiny of Offers :</u> a) The offers qualified as per PQR will be taken up for technical scrutiny. b) The technical offers will be scrutinized as per specification and drawing requirement. c) The Supplier registration forms of technically suitable offers will be evaluated by MISCC in line with supplier evaluation, Approval & Review procedure. d) Final Recommendation will be given by MISCC to include the Suppliers in PMD and for ordering the subject items.
