PREAMBLE OF PRICE BID

1.0. This Price Bid consists of three Schedules:

1.2 Schedule B

Schedule B gives the details of free issue materials given by BHEL.

1.3 Schedule C

Schedule C gives the details of Tools & Tackles provided by BHEL on Chargeable Basis.

2.0 The work to be carried out under the contract shall, except as otherwise provided in tender conditions, include all labour, materials, tools, plant, equipment, and transport which may be required in preparation of and for full & entire execution and completion of the Works. The descriptions given in the Schedule of Quantities shall, unless otherwise stated, be held to include waste on materials, carriage and cartage, carrying in return of empties, hoisting, setting, fitting and fixing in position and all other labours necessary in and for the full and entire execution and completion as aforesaid in accordance with good practice and recognized principles as laid down in Technical Specification & elsewhere in Tender Specification.

3.0 The price bid should not contain any condition. Conditional price Bids shall be summarily rejected.

4.0 The bidder should not leave any column blank in Price Schedules.

5.0 Price Quoted shall include all taxes, & duties except GST.

6.0 **Unless otherwise specified in the items involving cement or reinforcement steel, these items shall be issued free of cost by BHEL.**

ANNEXURE-II

Special conditions of contract

Name of work :- Providing anti mosquito treatment work by using fogging machines in BHEL Township,

1	Contractor shall have to take all safety measures/ precautions for his workmen before and during execution of the above work.
2	The area of BHEL Township is spread over 6.00 km x 6.00 km (approximate).
3	The hazardous chemicals shall be stored safely in store in locked condition and shall be handled with all care / precautions as recommended by the manufacturer.
4	The pest control operation shall be done by only those agencies, which have been approved by Licensing Authority. The Pest control operators / agencies should provide, along with their techno-commercial bid, License for Permission to stock and Carry-out Commercial Pest Control operations. Their License should be valid for entire duration of their contract (License shall have to be compulsorily renewed before its expiry date to cover the total contract period, otherwise the contract may be cancelled with penal action as deemed fit by the department).
	In case the tenderer submits an expired licence along with his techno-commercial bid , he shall be required to give an undertaking in writing that he would , upon award of work but within the time frame as specified by the department , submit the licence covering the entire contract period . Only after submission of the required licence shall the successful tenderer be allowed to commence the work failing which penal action as deemed fit shall be taken against the contractor.
5	A log book shall be maintained by the contract operating section of TCL/BHEL to keep a record of fogging operation . Such a record shall be signed jointly by the contractor as well as the Engr-in-charge. A daily attendance register shall also be maintained by the Engr-in-charge to keep a record of deployment of operator and helpers by the contractor.
