

Annexure-IA
Pre-Qualification Requirement (PQR) for Numerical relay and Networking system
under procurement through PI 240992437

1. Technical Experience

- 1.1. The Bidder must have manufactured, supplied and commissioned under a single contract at least 100 number of Numerical relays with IEC 61850 communication protocol in at least one Thermal Power Station of rating 250MW or above five years prior to the date of techno-commercial bid opening date.

Document required: Bidder to furnish unpriced P.O & Invoice copy in support of manufacture & supply and MOM with Customer/ Site or Customer email/ letter or any Customer document for commissioning status. Bidder shall also furnish Contact person details at Customer end.

- 1.2. The Bidder must have engineered, manufactured, supplied and commissioned under a single contract networking of at least 100 number of Numerical relays in one Thermal Power Station of rating 250MW or above five years prior to the date of techno-commercial bid opening date.

Document required: Bidder to furnish unpriced P.O, Invoice copy & Customer approved drawings in support of Engineering done, supply and MOM with Customer/ Site or Customer email/ letter or any Customer document for commissioning status. Bidder shall also furnish Contact person details at Customer end.

Note:

- i. In case bidder is a holding company, the technical experience referred to in clause 1.1 & 1.2 above shall be of that holding company only (i.e. excluding its subsidiary/group companies).
- ii. In case bidder is a subsidiary of a holding company, the technical experience referred to in clause 1.1 & 1.2 shall be of that subsidiary company only (i.e. excluding its holding company).
- iii. In case of works executed under a contract that had been awarded on a Joint Venture or to a consortium partners, the experience of individual Joint Venture partner/ consortium partner shall be considered limited to the scope of that partner under the said contract.

Document Required: Bidder to furnish valid Joint venture or Consortium agreement

2. Financial Position:

- 2.1. Bidder's Net Worth for last three financial years should be positive.
- 2.2. Bidder's annual gross revenue from Numerical relays & Networking items for best three years i.e. 36 months out of last five financial years as annualized should be more than Rs. 500 Lakhs.

Document required: Bidder to furnish a certificate issued by a practicing Chartered Cost Accountant (With membership number and firm registration number), certifying the claims, required as per clause 2.1 and 2.2 above OR Annual Audited Balance sheet along with Profit and Loss account satisfying above clauses 2.1 & 2.2.

Note:

- i. In case bidder is a holding company, the Financial Position criteria referred to in clause 2.0 above shall be that of holding company only (i.e. excluding its subsidiary / group companies)
- ii. In case bidder is a subsidiary of a holding company, the Financial Position criteria referred to in clause 2.0 above shall be that of subsidiary company only (i.e. excluding its holding company).
- iii. In case a bid is submitted by a Joint Venture (JV) or in Consortium of two or more firms as partners, joint venture/ consortium must comply the following minimum criteria:
 - a. All the partners of the JV/ Consortium must meet individually the Financial Position criteria given at 2.1 above.
 - b. The lead partner must meet, not less than 50% of the financial position Criteria given at para 2.2 above and 100% of the Technical Experience criteria given at 1.1 above. Each of the other partner(s) individually must meet not less than 25% of the criteria given at 2.2 above.

3. Organizational Capability

- 3.1. The Bidder must have manufactured minimum 500 number of Numerical relays on an average per year in the past two years from the date of techno-commercial bid opening date.
- 3.2. The Bidder shall have after sales service support set-up in India with trained engineers for providing prompt product repair/ rectification, testing and commissioning support.

Document required: (i) Bidder to furnish a certificate issued by a practicing Chartered Cost Accountant (With membership number and firm registration number), certifying the claims, required as per clause 3.1 OR PO and invoice copies. (ii) Bidder to furnish authorization letter for Indian service centre for performing services like product repair/ rectification, testing and commissioning in India along with the list of testing/ repairing equipment and List of service/ commissioning Engineers with their qualification.

Note:

1. The bidder shall furnish documentary evidence in support of the qualifying requirement stipulated as above.
2. Price bid of only techno-commercially qualified vendor acceptable to customer shall be opened.
