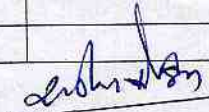

	Both Part - I and Part - II should reach in a box kept in our Tender Room before 11 : 00 a.m. on due date in two separate sealed envelopes clearly marked with "Enquiry No. Dated & Due Date : Part - I Technical and Commercial Bid" on 1 st envelop and "Enquiry No Dated & Due Date Part - II "Price Bid" to be marked on 2 nd envelop. Both envelopes should be sealed in the 3 rd envelope. The Enquiry No. Dated and Due Date are to be mentioned on this envelope also. Only part - I will be opened on the same day (i.e. tender opening day) after 2:00 pm. After scrutiny of Part -I, the price bid viz, Part - II will be scrutinized only for those offers which are meeting all our technical and commercial requirements. For scrutinizing price bid which will be opened on a particular date, which will be intimated in advance to all such venders whose offers are found technically and commercially acceptable.. 1	BHEL's Standard Payment Terms:- For Indigenous supply : 100% payment in 90 days of receipt (45 days for MSE including NSIC/ Udyog Aadhar registered suppliers as per relevant act in force), subject to acceptance of material at BHEL, on direct presentation of the documents. For Foreign supply : 100% payment against unconfirmed & irrevocable letter of credit (LC) ,payable within 120 days. Note : The LC shall be established 2 month prior to shipment date, valid for period of 120 days, unless agreed otherwise. Payment terms of CAD payable on 120 days of BL/HAWB date shall be preferred for foreign supply.. [Note :In case deviation in payment terms, the loading shall be at base rate of SBI (as applicable on the date of bid opening; techno-commercial bid opening in case of two part bids) + 6% shall be considered for loading for the period for relaxation sought by bidders to arrive landed cost for comparison purpose.]
