1	Mill's having no supply experience with BHEL for respective material grade, are requested to furnish list of supply experience & corresponding Test certificates (date of TC should not be older than five years from BHEL tender date) for supply of technically identical/ similar or better grade (in terms of lower losses) of CRNGO coils / sheets to other OEM for Rotating electrical or power equipment manufacturers. Their offer against BHEL enquiry will be considered only when such vendors confirm clause-wise compliance of BHEL respective specifications.		Self-Declaration of quantity supplied along with name of customer and grade with copy of respective Test certificates to be submitted. Also clause wise compliance of BHEL respective purchase specifications.
2	Offers are invited preferably directly from mill, however authorized trading houses may also quote. Authorized trading houses have to submit a supplying Mill's authority certificate for participating in the tender in original for specific enquiry no. Exxxxxxx on the Mill's letter head duly signed by Mill's authorized signatory (with Full name, Designation, valid email & contact number) along with the offer. In the absence of the above authority letter, offer from stockiest/ trading houses are liable for rejection.		Certificate of being Original manufacturer or authorization letter from original manufacturer for Distributors/agents.
3	Vendors who are not registered with BHEL and participating in this tender shall submit duly filled-in Supplier Registration form which is available at BHEL web site www. bhel.co.in.		Copy of registration form to be submitted
4	Mills must have valid ISO-9001 certificate. For distributors/agents ISO certificate of principal to be submitted.		Valid ISO-9001 certificate. For distributor /Agents ISO Certificate of Principal to be submitted.
5	Vendors have to furnish self-declaration for having manufacturing capacity to supply within six months the full ordered quantity for the item quoted.		Self –Declaration is required

6	All correspondence and documents shall be in ENGLISH language. If any document provided by vendor is in any language other than English, it must be supported with its English translation.		Compliance
7	Vendor, using varnish otherwise as specified in BHEL specification, should inform name , brand and other details of Varnish (as per attached annexure-1 of BHEL Spec AA0851711) being offered for the material grade quoted against each respective tender requirement. BHEL reserves rights to ask Vendor for prompt supply of samples of ETS (with varnish coating offered by vendor) and sample of varnish.		For information, filled up Annexure-I to be submitted.
