E1493066 on the Mill's letter head duly signed by Mill's authorized signatory (with Full name, Designation, valid email & contact number) along with the offer. In the absence of the above authority letter, offer from stockiest/ trading houses are liable for rejection. 3	Vendors who are not registered with BHEL and participating in this tender shall submit duly filled-in Supplier Registration form which is available at BHEL web site www.bhel.co.in .		Copy of registration form to be submitted
4	Mills must have valid ISO-9001 certificate. For distributors/agents ISO certificate of principal to be submitted.		Valid ISO-9001 certificate. For distributor /Agents ISO Certificate of Principal to be submitted.
5	Vendors have to furnish self-declaration for having manufacturing capacity to supply within six months the full ordered quantity for the item quoted.		Self –Declaration is required
