2) **In case of delivery earlier than 30 days from scheduled delivery date (only if desired by BHEL through written request):**

Price will be calculated based on rates on the date one month prior to GST Invoice date. USD to INR rate of corresponding date will be considered (SBI TT sell value)

3) Any deviation w.r.t. PVC clause during execution of order may lead to rejection of material if not agreed thereof.
