4.	DELIVERY TERMS: Vendor to clearly mention place of Delivery. M/s. BHEL prefers 'CRX BHEL (i.e. Door Delivery)' as place of delivery. Please confirm.	
5.	DELIVERY PERIOD: Delivery period to be quoted in no. of weeks/months from the date of receipt of Purchase Order.	
6.	BHEL PAYMENT TERMS : 100% payment in 90 days of receipt (45 days for MSE including NSIC / Udyog Aadhar registered suppliers as per relevant act in force), subject to acceptance of material at BHEL. Any deviation from the above payment terms, if accepted (by BHEL), shall be loaded @ SBI base rate + 6% for the purpose of bid evaluation.	
7.	PENALTY: Subject to force majeure conditions, penalty shall be 0.5% of the total order value per week of delay or part thereof, subject a maximum of 10% of the total order value. Total order value above shall be item wise, lot wise order value.

12.1	This has reference to Government of India Circular no. P-45021/2/2017-BE-II dt 15.06.2017 for Preference to Make in India and furtherance of the Public Procurement notified , the ministry of Heavy Industries & Public Entities (HI & PE) notification No. 9/4/2019 HE & MT dt. 8/6/2018, DHI Notification Dt. 8.6.2018 , circular no. 05 of 2019-20 & subsequent order issued by the respective nodal ministry with immediate effect. In The Event of any nodal ministry prescribing higher or lower percentage of purchase preference and/or local content in respect of this procurement, same shall be applicable. The purchase preference, if estimated value of procurement of such goods is more than Rs. 50 lakhs then based on confirmation issued by indenter about item/product nature to be divisible/splitting (clause 15 b shall be followed)	

	a) Default margin of purchase preference shall be 20% to local supplier with default minimum local content of 45% for all items, unless any change prescribed by Nodal Ministry b) Purchase preference shall be given to local supplier in all procurement undertaken by procuring entities in the manner as preferred hereunder i) Among all qualified bids the lowest bid will be termed as L1 . 12.2.1	The local supplier at the time of tender, bidding or solicitation shall provide self certificate that item offered meet the minimum local content 45% and shall give details of location at which the local value added in is made.	
12.2.2	In case of procurement for a value in excess of Rs. 10 Crore , the local supplier shall provide a certificate from the statutory auditor or cost auditor of the company giving the percentage of local content.	
12.2.3	False declaration will be breach of the code of Integrity under Rule 175 (iii)(i)(h) of the General Financial Rules for which a bidder or its successors can be debarred for up to two years as per rule 151 (iii) of general Financial Rules along with such other action as may be permissible under law.
