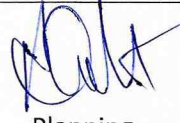
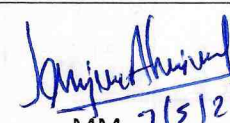

03.	The Bidder shall have during the immediately preceding three years, an Average Annual Turn Over of not less than Indian Rupees 3.5 Lakhs.	The Bidder shall furnish audited profit and loss account and balance sheet for the immediately preceding three years.	
04.	Bidder should have in-house facility for following: • Manufacturing facility of Dough Molded Components, Polycarbonate sheet & its molded components & Nylon Components. • Qualified Engineer for interpretation/ conversion of drawing & specification. • Qualified quality Inspector. • Qualified artisans for manufacturing. • Manufacturing Quality Plan for in-house similar work.	Self-declaration of in-house facility of letter head. Photographs of manufacturing & testing facilities. If required, Compliance certificate from BHEL SCR team consist of members from SWE, QSG, SWM & MWX department after vendor works visit.	
05.	Bidder should be ISO 9001 compatible organization with valid certificate on tender submission date.	Copy of certificates.	
06.	Bidder must not be under category banned or debarred/hold from dealing by BHEL/PSUs/Gov. of India on tender due date/time.	Self-declaration letter head.

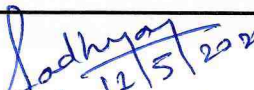
1. After satisfactory fulfillment of all the above criteria / requirement, offer shall be considered for further evaluation as per NIT and all other terms of the tender.
