Pre-Qualification Requirements (PQR) for Bidders

BHEL Tender No. –

The documentary evidence of the bidder's qualification to manufacture and supply the equipment, if its bid is accepted, shall be judged whether the bidder has the technical, financial, and other capacities and capabilities.

Bidders must meet following Technical & Financial criteria as Pre-Qualification Requirement (PQR) for the tender. Bids not meeting these requirements as stated below shall not be considered for further evaluation.

A. Technical:

- 1.0 Bidder shall be an Indian manufacturer of Transportable Oil field application Electrical Power Control Rooms - PCRs (MCC house / AC-PCR / DC-PCR / SCR House / VFD House / NGR House / Transformer House / E-Room / IRD House) and supplied minimum 01 (one) number during last 05 (Five) years (to be reckoned from the Bid opening date). Bidder's Invoice copy date as proof of supply shall be considered as date of supply to meet this criteria.

Purchase Order copy / Contract Copy and Invoice Copy should be enclosed with the bid, as proof of supply.

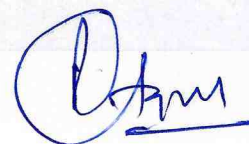
Bids from parties other than manufacturers shall not be considered.

- 2.0 Bidder shall have adequate manufacturing facility of their own for manufacturing and assembly of Transportable Oil field application Electrical Power Control Rooms - PCRs (MCC house / AC-PCR / DC-PCR / SCR House / VFD House / NGR House / Transformer House / E-Rooms / IRD House) complete with Electrical Motor Control Center (MCC) panels.

The bidder shall submit proof of its manufacturing facility with the bid. Acceptable documentary proof in this regard shall be as under :

- i) Quality certifications for the facility for such items as detailed at 1.0 issued by independent certification agencies **OR** Copy of Invoice(s) for such items as detailed at 1.0, shipped from their manufacturing facility. In case bidder has supplied such items as detailed at 1.0 to BHEL, such proof shall also be acceptable.
- ii) Valid Certificate of Incorporation of the manufacturing facility in India / Valid Uddyog Aadhar number certificate/ Government approval for manufacturing facility. In case bidder is already registered with BHEL Bhopal, then bidder to also indicate their registered vendor code.

B. Financial:

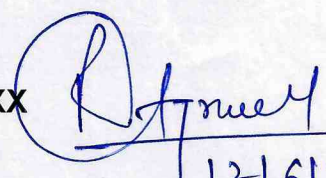
- 1.0 Bidder to submit audited financial annual report (Balance Sheet and Profit & Loss account) for last three consecutive years (2016-17, 2017-18, 2018-19). Alternatively a certificate issued by a practicing Chartered Accountant or Cost Accountant (with membership number and Firm Registration Number), certifying the Annual Turnover & Net worth for last three consecutive years (2016-17, 2017-18, 2018-19) shall also be acceptable.
- 2.0 Bidder's average annual financial turnover during the last three consecutive years (2016-17, 2017-18, 2018-19) should be at least Rs 5.47 Lakhs.
