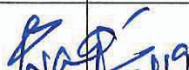

Moreover, either such an agent could bid on behalf of the manufacturer or the manufacturer could bid directly but not both in the same tender. In case bids are received from the manufacturer and also from his agent, bid received from the agent shall be ignored.
