3. On due date only techno-commercial offer shall be opened and after scrutiny, vendors who are found technically in line with our requirement, will be asked to participate in reverse auction or their price bid shall be opened, for which separate advance intimation shall be given.

4. Please confirm supply of items as per enquiry. All Test certificates & Guarantee certificates must be furnished in triplicate.

5. Offer must be in line with our technical specification/drawings. Deviation, if any, should be clearly indicated.

6. Replacement of Rejected Goods: In case of rejection due to non compliance to agreed specification and for reasons attributable to the vendor, the materials shall be replaced by vendor free of charge on 'FOR BHEL works basis' including all other cost elements such as total transportation, insurance, any other taxes/levis etc as applicable.

7. No enhancement of rate for whatever cause will be allowed once the quotations accepted and the order is placed. Withdrawal from the quotation after it is accepted or failure to make the supply within the scheduled period will entail cancellation of the order in addition to recovery of losses from the successful bidders.
