ANNEXURE-I

**ELIGIBILITY CRITERIA FOR REGISTRATION OF PIPING WITH VENDOR MATERIAL
(PVM CATEGORY)**

- 1) Indian Vendors who have adequate experience in fabrication industry which includes welding, machining etc., with a Financial Aspect – **Rs 10 crore** turnover per year for the past 4 years for piping fabrication and with a financial aspect of **Rs 1 crore** turnover per year for the past 4 years for Tanks & vessels fabrication.
- 2) **Indian Supplier Registration Form** along with the required statutory documents and supporting enclosures as per as per our Indian Supplier Registration Form should be submitted.
- 3) The company should have been in **continuous business** for the previous **4 financial years**
- 4) **Experience list** in the field of piping/piping component fabrication shall be furnished for the previous **3 financial years**
- 5) The firm should have **IBR approval** for undertaking IBR jobs.
