1. Pre-Qualifying Requirements:

Bidder has to provide the required details as per TECHNICAL PQR in its Techno-Commercial offer and has to note that bids of only those bidders shall be evaluated who meet the Technical Pre-Qualifying requirements.

2. Bidders have to note that this is a Conditional Tender enquiry and the price bid (Part-II) opening/RA participation of a bidder shall be subjected to following conditions:

- Qualifying Technical PQR.
- Techno-commercial recommendation by BHEL.
- Approval of bidder by End Customer i.e. M/s TSGENCO

Bidders have to note the following w.r.t Bill of Material document listed in Attachment-II of Tech. Spec. (vol. ii., section 1, Sheet 6 of 12): -

Bidder has to make first submission of BoM within 1 week of CAT-I approval of primary documents and subsequent revision within 1 week of BHEL comments.

Main Supply for Stage-II (i.e Unit-III, IV & V): Within 4 months from date of manufacturing clearance by BHEL.

Supply of Mandatory Spares: Within 3 months from BHEL clearance. Separate manufacturing clearance will be issued for Mandatory Spares.

Notes:

- A. Clearance for Stage-2 quantities shall be within 03 years from the date of Purchase Order, in line with clause No. 6 of General Commercial Terms & conditions of GCC Rev. 07.
 - B. The end period specified is for completion of the deliveries. Deliveries to start progressively so as to meet the completion schedule.
 - C. The delivery conditions specified are for contractual LD purposes, however BHEL may ask for early deliveries without any compensation thereof.
5. Evaluation will be done on overall L1 (Total cost to BHEL excluding GST) basis with necessary loadings as applicable.
 6. CIF is nil for this package
 7. **Over all (%) Quantity Variation:** The variation on overall package value due to changes in the scope shall be $\pm 0\%$ of the total contract value.
 8. Bidders have to note that Deviations from NIT are generally not acceptable. Deviations, if any, are to be listed out clearly, as per Annexure-II (Deviation Sheet – Cost of Withdrawal), of GCC Rev 07, in techno-commercial offer. Any deviation mentioned or shown separately or found hidden in offer, will not be taken cognizance of.

In case of deviations from NIT, the bidder shall give the cost of withdrawal of such deviation in Price Bid, as per Annexure-II, Deviation Sheet (Cost of Withdrawal) of GCC Rev-07. For multiple deviations, all deviations are to be mentioned in “Deviation Sheet” and “cost of withdrawal” must be mentioned separately against each deviation.
 9. If any bidder has mentioned the term Not Applicable / Not required / Not Quoted in BHEL price format, the same to be substantiated by the bidder. If such item is required to be supplied for system completion in future, same will be supplied free of cost by Vendor.
 10. In case of joint bidding, Bidders shall be required to furnish scope matrix which should be clearly defined between them along with the offer for the complete scope as per NIT.

11. In line with clause no 26 of GCC Rev. 07 (Instructions to Bidders), bidders are requested to go through the mentioned orders related to Make in India and furnish the following:

- The local supplier at the time of tender, bidding or solicitation shall be required to provide self-certification (as per enclosed format) that the item offered meets the minimum local content as per above mentioned orders (and indicated below at sl. No. 01) and shall give details of the location(s) at which the local value addition is made.

Following may pls. be noted by the bidders:

1. Min. Local content value for subject tender is 100%
2. Tendered package is divisible
3. Margin of purchase preference shall be 20%.

12. Bidders need to indicate the quoted freight charges in percentage of total Quoted Ex-works, in their unpriced format.

13. The bidders (who are not registered with BHEL-PEM)- Online Registration Portal is operational in BHEL. Non-registered bidders, who wish to apply for registration with BHEL-PEM, may apply through Online Registration Portal available at www.bhelpem.com → vendor section → Online Supplier Registration. All credentials and/or documents duly signed and stamped related to registration has to be uploaded on the website and submit the application for registration. One set of hard copy of the filled-up SRF downloaded from Online Registration Portal duly signed and stamped has to be submitted.

14. BHEL reserves the right to go for Reverse Auction (RA) (Guidelines as available on www.bhel.com) instead of opening the sealed envelope price bid, submitted by the bidder. This will be decided after techno-commercial evaluation. Bidders to give their acceptance with the offer for participation in RA. Non-acceptance to participate in RA may result in non-consideration of their bids, in case BHEL decides to go for RA. (for details refer Cl No. 13.0 of Instruction to Bidders of GCC Rev.07)
