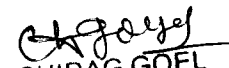

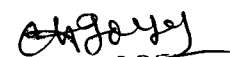

Special Provision for Micro and Small Enterprises (MSE)

Applicable for INDIAN Manufacturers only:

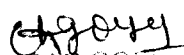
