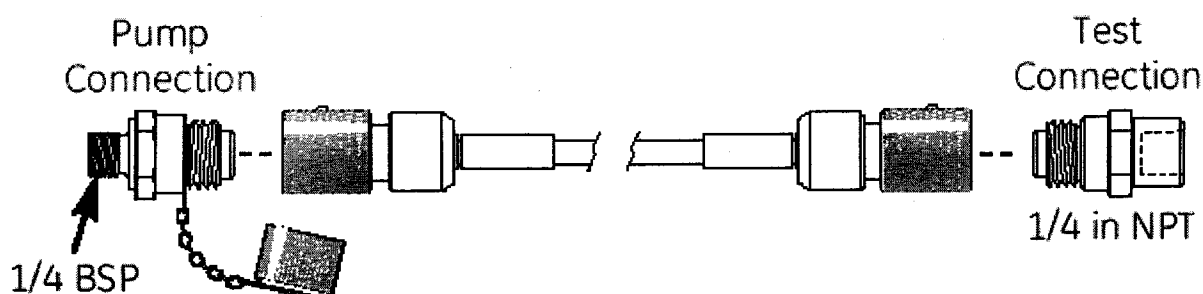


Representative diagram of the Hydraulic Hand Pump Required
