SPECIFICATION FOR NYLON SOCKS

1. The socks shall be made up of 100% Nylon material NAVY BLUE&BROWN in TWO colours.
2. The construction shall be rib knitted and reversible type.
3. Multi filament stretch nylon yarn used in knitting, linking and specking the socks shall conform to the requirement as per IS: 5084-1990.
4. The heel, sole and toe portions of the socks should be knitted in plain stitches with splicing. The splicing should be uniform throughout and the spliced portion free from creases or folds.
5. The socks shall be securely linked at the toe. The linking shall be elastic smooth knots. Linking shall not give way when socks are stretched to the full extent of stretch ability of the socks.
6. The socks shall be of free size, to the requirement of any adult.
7. The socks weight of the socks shall be as per IS: 5084-1990.
8. The socks shall be free from noticeable manufacturing defects as per IS: 5084-1990.
9. Venders are requested to submit the sample for evaluation along with the Technical bid. Failing to do so would result in rejection of offer.
10. Supply subjected to 100% inspection.
11. Samples are required for our evaluation along with offer. Offer without sample is not acceptable.
