In case BHEL manufacturing clearance date is later than date of cat-1 approval of Primary drawing/documents, then for delay analysis submission/re-submission time of Primary drawing/document shall not be considered.

DRG SCHEDULE: -

- i) For Primary documents - GA, Foundation Detail (as required) and Data sheet of Machine / Equipment with detailed BOM. & Inspection Check List / Manufacturing Quality Plan of machine/equipment.

(Revision 0 of Drawings shall be submitted within 21 days from PO & subsequent revisions within 10 days of comments received from BHEL. BHEL shall furnish comments / approval on each submission within 18 days from receipt.)

- ii) For Secondary documents - O&M Manual & Erection Procedure {within 30 days of issuance of MDCC.}

- The end period specified is for completion of the deliveries. Deliveries to start progressively so as to meet the completion schedule.
- The delivery conditions specified are for contractual LD purposes, however BHEL may ask for early deliveries without any compensation thereof.
- Non-applicable drawings shall be decided during execution of the package.
- Wherever schedule of drawings/documents submission / re-submission is stipulated in the Technical Specifications, same shall be superseded by delivery specified in NIT.

21. Prices shall be firm till completion of the contract.

22. In case of joint bidding, Bidders shall be required to furnish scope matrix which should be clearly defined between foreign bidder and their Indian representative along with the offer.

23. **Evaluation Criteria:** - Evaluation will be done on item wise on total cost to BHEL [Total Cost to BHEL including applicable loading (if any)] basis. GST shall not be considered in evaluation.

24. Overall (%) variation in contract values (due to changes in the scope) shall be limited to +/- 0%. This will prevail over the quantity variation Cl. No. 6.0 of GCC, Rev. 06.

25. BHEL reserves the right to go for Reverse Auction (R.A.) (Guidelines as available on www.bhel.com) instead of opening the sealed envelope price bid, submitted by the bidder. This will be decided after techno-commercial evaluation. Bidders to give their acceptance with the offer for participation in R.A. Non-acceptance to participate in R.A. may result in non-consideration of their bids, in case BHEL decides to go for R.A.

IMPORTANT INSTRUCTION TO BIDDERS IN CASE OF REVERSE AUCTION

The Bidder has to quote the Single Price (**Total Cost to BHEL availing input tax credit**) in Reverse Auction. Price has to be inclusive of Packing & Forwarding charges, all the routine & type tests as per tender scope, Freight charges, Insurance charges (if applicable), Goods and service tax as applicable etc. including Cost of withdrawal and loading (if any).

26. H1 bidder (whose quote is highest in online sealed bid) will not be allowed to participate in further RA process.
27.
