TECHNO-COMMERCIAL BID (Part-I)

Sub :- Labours oriented work for operation and maintenance of LPG plant, Metal Cutting Gas (MCG) plant, air compressor plant and other auxiliaries.

Sealed tender is invited in two part bid system for carrying out the work as per the details given in scope of work (Annexure-I).

1.0 Techno-commercial Bid (Part-1): The first envelop shall contain the Techno-commercial bid as per the enclosed Annexure – I, II, III, IV, V, VI & VII duly signed by the contractor and with copies of relevant documents, tender cost and EMD. The envelope shall be super scribed “Techno-Commercial bid Enq. No. (name of work)”.

1.1 Price bid (part-2): The second envelope shall contain the price bid only. The price shall be quoted in price bid format only. The envelope shall be sealed and super scribed “Price Bid Enq. No.(name of work)”.

1.2 Both the above two envelopes shall be kept in another sealed cover. The cover shall be super-scribed with “Quotation for Enq. No..... (name of work)”, Due date and it shall be addressed to AGM (GPX). The tender can be sent through post or dropped to Works Tender Box Tender Room, ADM Building, Ground Floor of BHEL, Bhopal – 462021, before due date & time. (It should also contain Tenderer address).

2.0 Eligibility criteria/ qualifying requirement:-

Only those contractors registered in WEX & Field Maint. Divisions works directory category code WEX-003 (Operation and routine maintenance of plants, equipment and auxiliaries in factory area & outside) are eligible to apply. The offer of other parties will not be considered and will be rejected.

3.0 Tender terms:-

- The tender should be valid for three months.
- The tenderer shall quote considering the statutory prescribed minimum wages as recommended by BHEL, bids lower than the minimum statutory amount as recommended by BHEL shall be rejected.

- c) BHEL, Bhopal reserves right to accept the tender in full or in part and tenderer shall be bound to perform the work as per amount quoted in tender.
- d) BHEL, Bhopal also reserves right to reject the tender and disqualify the tenderer from participating in tender if it is found that any relative of the tenderer is working in tendering department.
- e) If required the tenderer may visit the site to assess the site conditions and volume of work to be physically executed before submitting the tender. Any claim or condition after submission of tender shall not be entertained.
- f) The other terms and conditions are as per annexure-I, II, III, IV, V, VI & VII.

4.0 Tender cost, Earnest Money Deposit (EMD) and security deposit :-

Note:- Tender Cost/EMD/SD are to be deposited only in electronic Mode/online. E-Payment option available on www.bhelbpl.co.in under caption new link or <https://www.bhelbpl.co.in/qcins/iccs.htm> and the deposit slip to be enclosed with technical Bid.

- a) **Tender cost** of Rs. 200/- (GST extra) shall be deposited online and submit the proof of deposition along with the tender. Tender received without remittance of tender cost will not be considered further and will be rejected.
- b) **Earnest Money Deposit (EMD):-** of Rs. 15360/- (GST extra) shall be deposited online and submit the proof of deposition along with the tender. Tender received without remittance of EMD will not be considered further and will be rejected.

EMD for this tender will not be required from those contractors who had deposited one time EMD of Rs. 5.0 Lakh in BHEL Bhopal. The proof of deposition of one time EMD of Rs. 5.0 Lakh is to be submitted by them along with the tender documents.

Note:- EMD by the Tenderer will be forfeited if:-

- i) After opening the tender, the tenderer revokes his tender within the validity period or makes any modification in his tender which is not acceptable to BHEL.
- ii) The Contractor fails to deposit the required Security deposit or commence the work within the period as per LOI/ Contract.
- c) **Security Deposit (SD) :-** will be collected from the successful tenderer @ 5% of contract value (50 % of SD before start of work and rest 50 % will be deducted from bills). The EMD of successful tenderer will be converted to SD. The SD deposited will be refunded after completion of work order. EMD and SD do not carry any interest.

5.0 PF No., ESI No., GST No., PAN No. & Labour License No. :-

The relevant copies of PF No., ESI No., GST No., PAN No. & Labour License No. (if applicable) shall be submitted with tender. In case, the successful tenderer does not have above further action will be taken as per BHEL rules and guidelines.

6.0 Compensation of Delay/ Penalty Clause:-

In case the contractor does not carry out the contractual/statutory obligations and the general terms and conditions or the services rendered by him are found to be unsatisfactory, it will brought to his notice first to rectify the deficiency/ anomaly within specified time (3 days) failing which BHEL reserves the right to impose penalty (0.5% per week of contract value will be deducted after 3 days time, limited to maximum 10% of contract value) and/or terminate the contract without assigning any reason whatsoever. In such an event, no damages will be payable for short closure of the contract and EMD will be forfeited. The remaining work may be awarded to any other suitable agency at risk and cost of contractor.

7.0 Payment terms :-

The payment will be made on monthly basis based on actual man days per month on submission of invoice to BHEL. Taxes (if any) shall be paid only when relevant bill/invoice bearing registration no. along with the receipt/challan copy of deposition of tax is submitted. In case MSME payment within 45 days and for others 60 days.

Note:- Any loss or delay in input tax credit (ITC) due to reasons attributable to contractor to be recovered from contractor with interest.
