The Plate Bending Machine shall be as per specification No.PCPS:48PLM:NLC:01/Rev 00-Part A&B. 2.Prices shall be quoted on FOR destination basis only & the Freight cost shall be indicated separately either in percentage basis or in lumpsum basis separately. Insurance shall be by Vendor. 3. In case of order, materials are to be despatched to site through vendor's own carrier on Freight paid basis & on door delivery basis, as per our despatch instructions & only after obtaining clearance from BHEL. 4. Tender will be evaluated on total package basis. 5. Please submit Annexure-B&C (commercial terms & conditions), duly filled, signed & sealed. 6. Risk purchase clause is applicable. 7. Prices shall be firm till the completion of supply, in case of order. 8. Guarantee/Warranty shall be 18 months from the date of commissioning or 24 months from the date of supply whichever is earlier. 9. Following are the Loading criteria, applicable in this tender and BHEL will consider the ranking after the loading is applied as referred below, wherever deviations are observed. i)) Payment Term. Payment through Bank is not preferred. In case of Payment through Bank is opted by Supplier, BHEL prefers documents submission through bank with copy of LR and door delivery of Goods to Site/Stores with Consignee copy attached. In this case Loading will be 3% on the offered value. In case of Direct to Site (DTS), only 90% through bank will be considered. Offers of indigenous Suppliers with payment terms as LC/Advance Payment are liable for rejection. Option-1: Payment term is 100% direct payment after 45 days from the date of dispatch against site acknowledgement and against 10% PBG valid for the warranty period. (or) Option-2: Payment term is 90% direct payment after 45 days from the date of dispatch against submission of dispatch documents and 10% PBG valid for the warranty period and balance 10% against site acknowledgement. For this option -(b), a loading of 2% on the 90% of the offered value shall be made. Any deviation in the above payment term will attract loading as mentioned below. "Base rate of SBI (as applicable on the date of bid opening. Techno-commercial bid opening in case of two part bids) + 6% shall be considered for loading for the period of relaxation sought by bidders. ii)) Liquidated Damages / Penalty Liquidated damages shall be 0.5% of the total order value per week or part thereof subject to a maximum of 10% of the total order value.
