1	Bidder shall be a regular manufacturer or authorized agent of manufacturer for BW fittings (Traders / distributors / dealers are not acceptable). 2	Bidder must have valid ISO/equivalent certification.	Copy of valid ISO 9001:2015 or written down procedure.

4	Bidder shall have prior experience in successful manufacture and supply of SA234 fittings of Gr.91 / Gr.92 specification in “Seamless” construction as indicated below- 1. If quoting for Enq SI No 1 - Minimum OD – 88.9 mm 2. If quoting for Enq SI Nos 2, 3, 4, 5 or 10 - Minimum OD – 508 mm 3. If quoting for Enq SI No 6 - Minimum OD – 711 mm 4. If quoting for Enq SI Nos 7, 8 or 9 - Minimum OD – 33.4 mm Experience in supply of Tee meeting the above criteria, will qualify for Reducer and Elbow. Experience in supply of Elbow or Reducer will qualify only for the respective item. Supply experience being furnished shall not be prior to 3 years from the date of the Enquiry. For indigenous Start-ups and MSE bidders alone, prior experience is relaxed to last 4 years from the date of Enquiry. Supply experience post Part I bid opening date will not be considered.	1. 6	Firm should have made a turnover of at least Rs. 40 Lakhs for anyone of last 3 audited Financial Year (FY 2018-19, 2017-18 or 2016-17). In case of foreign bidder, financial turnover shall be an equivalent of Rs. 40 Lakhs in their regional currency. For indigenous Start-ups and MSE bidders alone, financial turnover of Rs. 40 lakhs is relaxed to Rs. 20 lakhs. For foreign bidder, exchange rate as on the date of Part I opening will be considered for arriving equivalent turn over in INR.	1. Indigenous bidders shall submit audited Company Financial statement- Balance Sheet and P&L statement for anyone of the past 3 years (FY 2018-19, 2017-18 or 2016-17) meeting financial turnover criteria. 2. In case of foreign bidder, recent credit rating report issued by any reputed third party business rating agency like D&B, Credit reform will be accepted in place of the above.	
7	Bidder should be in current business	1. Indigenous bidders shall submit audited Company Financial statement- Balance Sheet and P&L statement for the FY 2018-19. 2. In case of foreign bidder, recent credit rating report issued by any reputed third party business rating agency like D&B, Credit reform will be accepted in place of the above.	
8	Indigenous vendors referred to BIFR or Firms having strictures/hold by any other government agencies will not be considered (Not applicable for Import vendors).	Bidder's compliance.	
9	Bidder to submit all supporting documents in English language. If documents submitted by bidder are in a language other than English, a self-attested English translated document shall also be submitted.	Translated documents (if applicable).

- Only the bids fulfilling PQR will be considered for further Techno-Commercial evaluation.
- Bidders proposing to avail Startup and MSE relaxations shall submit applicable documentary proof along with Pre-Qualification bid. In case the required documents are not submitted by the bidder, no relaxation will be provided. Relaxations are subject to bidder meeting technical and quality criteria of the PQR.
 - For Startups – Certificate of Recognition by Department of Industrial Policy & Promotion.
 - For MSE – Copy of UAM (notarized copy) for MSE registration along with CA certificate for FY 2018-19.
