 - Enq SI No 3 (a) and 3 (b) will evaluated as single item and ordering will be done on the most economical L1 vendor.
- Unit rate to be quoted-
 - For foreign bidder- 'CFR' Chennai port (all inc of P&F, inspection charges, freight etc)
 - For indigenous bidder- 'FOR' BHEL Trichy / Site basis (all inc of P&F, F&I, inspection charges etc)
- For foreign bidders, prevailing incidental charges for import purchase (presently @2.2%) and net customs duty (presently @5.5%) will be applicable on the rate quoted.
